

Reciprocity Agreement between the Irish Mathematical Society and the



New Zealand Mathematical Society

Main aim: The main aim of this reciprocity agreement is to establish a good working relationship and to provide a channel for the exchange of information between the two Societies.

The agreement between the Societies

In accordance with all bylaws and regulations governing both Societies (article 10 of the Irish Mathematical Society and article III of the New Zealand Mathematical Society), and after consultation and approval of their respective governing bodies the President of the Irish Mathematical Society and the President of the New Zealand Mathematical Society hereby sign this reciprocity agreement.

The Societies agree to exchange their publications in a timely manner either in hard or electronic format until further notice:

The Irish Mathematical Society will post as hard copy one copy of the Irish Mathematical Society Bulletin (a twice yearly publication) and any other publications it may produce to a designated address in New Zealand, the address to be designated by the New Zealand Mathematical Society.

Should it be so desired by the New Zealand Mathematical Society, or if such publications are produced only in electronic form in the future, then delivery will be in electronic format instead to a specified e-mail address.

The New Zealand Mathematical Society will post as hard copy one copy of the New Zealand Journal of Mathematics (a twice yearly publication) and any other publications (such as the Newsletter) it may produce to a designated address in Ireland, the address to be designated by the Irish Mathematical Society.

Should it be so desired by the Irish Mathematical Society, or if such publications are produced only in electronic form in the future, then delivery will be in electronic format instead to a specified e-mail address.

The Societies also agree to carry out all necessary tasks to facilitate the exchange of researchers and graduate students between both countries and to exchange invitations for all relevant activities organized by each Society.

The terms of this agreement may be changed at any time by mutual consent of the two Societies. This agreement may be terminated at any time by a simple request from one of the two Societies, provided this course of action has the approval of the appropriate governing bodies and is communicated as early as possible.

Reciprocal membership of the Irish Mathematical Society for a member of the New Zealand Mathematical Society

The Irish Mathematical Society recognizes to all full members of the New Zealand Mathematical Society in good standing, the right to become Reciprocity Members of the Irish Mathematical Society provided that he/she is not normally resident on the island of Ireland.

The reciprocity membership fee will be equivalent to 50% of the annual fee charged to full members of the Irish Mathematical Society. (The reciprocity fee is currently €12.50 or NZ\$25, payment in Euro would be appreciated.)

A Reciprocity Member will have the following rights:

- 1. He/she will receive either in hard or electronic format one free copy of the Bulletin of the Irish Mathematical Society. (At present hard copies are posted to members.)
- 2. He/she will be entitled to free registration at the Irish Mathematical Society September conference.
- 3. He/she will be entitled to attend and vote at Ordinary Meetings of the Irish Mathematical Society.
- 4. He/she will be entitled to a 10% discount at Foyle's bookshop in London either in person or online and to any future discounts negotiated by the Irish Mathematical Society. Details of Foyle's discount may be found here: http://www.maths.tcd.ie/pub/ims/Books/

Reciprocal membership of the New Zealand Mathematical Society for a member of the Irish Mathematical Society

Article III of the New Zealand Mathematical Society Constitution States:

"Ordinary membership of the New Zealand Mathematical Society shall be open to any person interested in the interests of the Society. Election to Ordinary membership shall be by vote of the Council (Article VI) upon written application and upon payment of the annual subscription. However a person who is not normally resident in New Zealand and who is a member of a Society with which the New Zealand Mathematical Society maintains a reciprocity agreement shall, upon application to Council, be admitted as and remain an ordinary member of the New Zealand Mathematical Society at a reduced subscription."

In this agreement the New Zealand Mathematical Society is establishing a reciprocity agreement with the Irish Mathematical Society.

Currently overseas residents who are fully paid-up members of societies with which the NZMS maintains a reciprocity agreement have their membership fee reduced by 50%. (The current fee is NZ\$18.)
