On the decomposition map for symmetric groups

Abstract Let \mathbb{R}^d be the \mathbb{Z} -module generated by the irreducible characters of the symmetric group S_d . We determine bases for the kernel of the decomposition map. It is known that $\mathbb{R}^d \otimes_{\mathbb{Z}} F$ is isomorphic to the radical quotient of the Solomon descent algebra when F is a field of characteristic zero. We show that when F has prime characteristic and I_{br}^d is the kernel of the decomposition map for prime p then $\mathbb{R}^d/I_{br}^d \otimes_{\mathbb{Z}} F$ is isomorphic to the radical quotient of the p-modular Solomon descent algebra.

1 Introduction

A basic problem in representation theory of symmetric groups is to express irreducible characters in terms of irreducible Brauer characters on p-regular elements for p a prime number, that is to find the decomposition numbers.

If *G* is the symmetric group S_d let $R^{\hat{d}}$ be the \mathbb{Z} -module generated by the irreducible characters of *G*, and let $R^{\hat{d}}_{br}$ be the \mathbb{Z} -module generated by the irreducible Brauer characters of *G*. Restriction of functions to *p*-regular elements induces a \mathbb{Z} -homomorphism $\xi : R^d \to R^d_{br}$; and this is known to be surjective. The decomposition numbers describe the kernel of this map, in terms of the bases of ir-

reducible characters and the irreducible Brauer characters. However, although the irreducible Brauer characters have nice parametrizations, they are not known in general (and finding all decomposition numbers is known to be as hard as the Lusztig conjecture for type A, [8]).

Therefore one asks whether there are different ways to describe the kernel of the decomposition map, for which explicit answers can be given. The aim of this paper is to give such a description. As an application, it gives a new characterisation of the radical quotient for the Solomon descent algebra.

Finding bases for the kernel of the decomposition map is done via symmetric functions. In this setup, it is equally good to replace the prime p by any positive integer r > 1. Let $R = \bigoplus_{d \ge 0} R^d$, this is a ring which is identified with the ring Λ of symmetric functions via the characteristic map [10, I.7]. Define ξ by restricting class functions to the set of r-regular elements; we are interested in the kernel of ξ which we denote by $I_{br}(R^d)$, or rather in the corresponding subgroup of Λ^d , denoted by $I_{br}(\Lambda^d)$. Let $\psi^r : \Lambda \to \Lambda$ be the ring homomorphism which takes the variable $x_i \in \Lambda$ to x_i^r . Any product $\psi^r(f) \cdot g$ of degree d where f has zero constant term belongs to $I_{br}(\Lambda^d)$; and we obtain \mathbb{Z} -bases consisting of functions of this form. This uses results by J. Nuttall [11] and G. Walker [17]. In particular this gives presentations for the Abelian groups R_{br}^d . These are given in terms of characteristic zero information, so we conclude that the problem of describing the kernel of the decomposition numbers.

The direct sum $I := \bigoplus_{d \ge 0} I_{br}(\Lambda^d)$ is an ideal of Λ , and this gives a presentation for the factor ring, and hence of the ring $R_{br} = \bigoplus_{d \ge 0} R_{br}^d$. We obtain that I is the ideal generated by the image $\psi^r(\Lambda^+)$ of symmetric functions Λ^+ with zero constant term. In case r = p prime, the map ψ^p may be thought of as a 'Frobenius twist'; on the level of symmetric polynomials it takes the formal character of a module for the general linear group to the formal character of its Frobenius twist. So in this case one could say, roughly speaking, that the kernel of the decomposition map for symmetric groups is determined by the Frobenius twist.

For a fixed *d*, the product of characters induces a ring structure on \mathbb{R}^d and also on \mathbb{R}^d_{br} . We take the integral form of \mathbb{R}^d given by Young characters, then for *F* a field of characteristic zero, $\mathbb{R}^d \otimes_{\mathbb{Z}} F$ is isomorphic to the radical quotient of the Solomon descent algebra \mathcal{D}_d , this was proved in [16]. When *F* is a field of prime characteristic p > 0, the radical quotient of the *p*-modular Solomon descent algebra was determined in [2], and also in [3]. Namely, it is isomorphic to the *F*-algebra obtained by reducing the Young characters modulo *p*. We show that this radical quotient is isomorphic to $\mathbb{R}^d_{br} \otimes_{\mathbb{Z}} F$. In particular this also gives information on the algebra structure of $\mathbb{R}^d \otimes_{\mathbb{Z}} F$. Namely, it is the quotient of the descent algebra obtained by base change from the characteristic zero radical quotient.

Part of this existed as a preprint a while ago. In the meantime, one aspect was used in [5] 4.4, and extended by supplying a hard calculation. Subsequently I learned through Manfred Schocker the connection with the Solomon descent algebra, and the last part of this note is only very recent.

2 Preliminaries

2.1 Let $\Lambda^+(n, d)$ be the set of all partitions of d with at most n parts. If $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_n)$ is a partition then $|\lambda|$ is the sum of the parts. Moreover, if r is a positive integer, then $r\lambda$ is the partition $(r\lambda_1, r\lambda_2, \dots, r\lambda_n)$. We also write λ^r for the partition whose parts are the λ_i , each of them r times. If λ, μ are partitions we denote by $\lambda \cup \mu$ the partition whose parts are those of λ and μ (abusing notation). We denote by \leq the lexicographic order of partitions. A partition λ is r-regular if it does not have r or more equal parts. We write $\lambda \sim_r \emptyset$ if the r-core of λ is \emptyset .

2.2 Let $R = \bigoplus_{d \ge 0} R^d$ where R^d is the Abelian group of generalized characters of the symmetric group S_d . Then R is a ring which is isomorphic to the ring Λ of symmetric functions. That is, $\Lambda = \lim \Lambda_{(n)}$, where $\Lambda_{(n)}$ is the ring of symmetric polynomials in n variables, and where the limit is taken via the \mathbb{Z} -linear maps $\Lambda_{(n)} \to \Lambda_{(m)}$ for $n \ge m$ defined by

$$x_i \to \begin{cases} x_i \ i \le m \\ 0 \ i > m \end{cases}$$

Let (-, -) be the inner product on R defined from the usual scalar product on R^d and making R^d 's for different d orthogonal. Let also (-, -) be the scalar product on Λ such that the Schur functions s_{λ} form an orthonormal basis. Then the characteristic map ch : $R \to \Lambda$ is an isometric ring isomorphism [10] I(7.3).

2.3 We fix an integer $r \ge 1$. There is a ring homomorphism $\psi^r : \Lambda \to \Lambda$ which takes x_i to x_i^r ; and it is compatible with the projections $\Lambda \to \Lambda_{(n)}$; see [17], [7]. Consider the case r = p where *K* is an infinite field of characteristic *p*. If *M* is a $GL_n(K)$ -module with formal character χ then $\psi^p(\chi)$ is the formal character of M^F where *F* is the Frobenius map.

2.3.1 By transport of structure, we get a ring homomorphism on *R* which we also denote by ψ^r . Suppose χ is a generalised character of S_d where $d \ge 1$; then via the characteristic isomorphism we obtain the following explicit formula for $\psi^r(\chi)$, namely we have for $g \in S_d$

$$\psi^{r}(\chi)(g) = \begin{cases} z_{r\mu} z_{\mu}^{-1} \chi(w_{\mu}) & \text{if } g \text{ is conjugate to } w_{r\mu} \\ 0 & \text{otherwise} \end{cases}$$

Here w_{λ} is an element of cycle type λ , and z_{λ} is the order of the centralizer of w_{λ} in S_d . Following [9], an element $g \in S_d$ is said to be *r*-element if each non-trivial cycle has length divisible by *r*, and *g* is *r*-singular if at least one cycle of *g* is divisible by *r*. Furthermore, *g* is *r*-regular if no cycle of *g* has length divisible by *r*. If r = p is prime, then this is the usual definition of a *p*-regular element of a group.

With this we have seen that $\psi^r(\chi)$ is supported on fixed point free *r*-elements of \mathcal{S}_d .

2.3.2 The map ψ^r has an adjoint with respect to (-, -), denoted by ψ_r , which is also a ring homomorphism of Λ and is compatible with the projections; this is a result in [17]. The map ψ_r can be defined as follows, on the complete symmetric functions h_d . Let $d \ge 1$, then

$$\psi_r(h_d) = \begin{cases} h_s \text{ if } d = rs\\ 0 \text{ otherwise} \end{cases}$$

By transport of structure we get a ring homomorphism of *R* which we also denote by ψ_r .

2.4 The following formula is due to J. Nuttall [11] . Let $\omega = e^{2\pi i/r} \in \mathbb{C}$; then we have for $d \ge 1$

(*)
$$\psi^r \psi_r(h_d) = \sum_{\alpha \in \Lambda^+(r,d)} m_\alpha(1,\omega,\cdots,\omega^{r-1})h_\alpha$$

where m_{α} is the monomial symmetric function; and $h_{\alpha} = \prod_{i=1}^{r} h_{\alpha_i}$ if $\alpha = (\alpha_1, \alpha_2, \cdots, \alpha_r)$. (This can be proved as follows. If H(t) is the generating function for the complete symmetric functions, then

$$\psi^r \psi_r(H(t)) = \prod_{i \ge 0} (1 - x_i^r t^r)^{-1},$$

see [17] 2.1. Now one observes that $(1 - (x_i t)^r) = \prod_{k=0}^{r-1} (1 - \omega^k(x_i t))$, and one uses [10] I(4.2).) Hence for any integer $s \ge 1$ we have

(**)
$$\psi^r(h_s) = \sum_{\alpha \in \Lambda^+(r,rs)} m_{\alpha}(1,\omega,\cdots,\omega^{r-1})h_{\alpha}$$

This can also be expressed in terms of Schur functions. Let s_{α} denote the Schur function corresponding to the partition α . By [10] I(4.3) and [10] ex. 17 p.50 we have

$$\psi^{r}(h_{s}) = \sum_{\alpha \in \Lambda^{+}(r,rs), \alpha \sim_{r} \emptyset} \sigma_{r}(\alpha) s_{\alpha}$$

Here $\sigma_r(\alpha)$ is the sign of the unique permutation $w \in S_r$ such that $\alpha + \delta_r \equiv w \delta_r \pmod{r}$, where $\delta_r = (r - 1, r - 2, \dots, 1, 0)$.

2.5 Let ω be as above a primitive complex *r*-th root of unity. We set

$$z := (1, \omega, \omega^2, \cdots, \omega^{r-1})$$

The values $m_{\alpha}(z)$ where $\alpha \in \Lambda^+(r, d)$ are calculated explicitly in [5]4.4. Here we only need a small amount of information which is not hard to obtain directly. The numbers $m_{\alpha}(z)$ are integers, and if *r* does not divide *d* then $m_{\alpha}(z) = 0$. This follows for example from 2.4.

Assume now that *r* divides *d*, say d = rs. Let m_i be the multiplicity of *i* as a part of α so that $\alpha = (\dots, i^{m_i}, \dots, 1^{m_1}, 0^{m_0})$, with $m_i \ge 0$ and $\sum m_i = r$. Let *q* be the greatest common divisor of the m_i . Then one shows that $m_{\alpha}(z)$ is divisible by r/q. (For example, take m_{α} with *r* variables, then the terms form one orbit under the action of the symmetric group S_r given by change of variables. Analysing this action gives the required answer). One deduces:

2.5.1 We have $m_{\alpha}(z) = \pm 1$ if and only if $\alpha = (s^r)$.

3 On \mathbb{Z} -bases of I_{br}

3.1 We fix an integer r > 1. For a character $\chi \in \mathbb{R}^d$, let $\xi(\chi)$ denote the restriction of χ to the set of *r*-regular elements of S_d . Let \mathbb{R}^d_{br} be the \mathbb{Z} -module generated by the $\xi(\chi)$, a submodule of the \mathbb{Z} -valued class functions on *r*-regular elements (see 2.3.1). When r = p is prime then $\mathbb{R}^d_{br} = \sum_{\lambda} \mathbb{Z}\beta^{\lambda}$, here the β^{λ} are the irreducible Brauer characters, which can be labelled by *p*-regular partitions of *d*. For a discussion of the decomposition map for finite groups in general, we refer to [15].

We have then a surjective \mathbb{Z} -homomorphism $\xi : \mathbb{R}^d \to \mathbb{R}^d_{br}$. For arbitrary r, it is proved in [9]4.2 that the set $\xi(\chi^{\lambda})$ for λ r-regular, is a free \mathbb{Z} basis for \mathbb{R}^d_{br} . [Here χ^{λ} is the irreducible character of S_d corresponding to partition λ , as usual.] Let $I_{br}(\mathbb{R}^d)$ denote the kernel of ξ , and define

$$R_{br} = \bigoplus_{d \ge 0} R_{br}^d, \quad I_{br}(R) = \bigoplus_{d \ge 0} I_{br}(R^d).$$

We have also a \mathbb{Z} -homomorphism $R \to R_{br}$ which we denote by ξ , extending the homogeneous restriction maps. Its kernel is $I_{br}(R)$ which is an ideal, and R_{br} has a ring structure such that ξ is a ring homomorphism. We are interested in $I_{br}(R^d)$ and $I_{br}(R)$; we will study their images under the characteristic isomorphism in Λ , which we denote by $I_{br}(\Lambda^d)$ and $I_{br}(\Lambda)$.

Let $\lambda = (\lambda_1, \dots, \lambda_n)$ be a partition of *d*. The symmetric function $h_{\lambda} = \prod_{i=1}^n h_{\lambda_i}$ corresponds under the characteristic isomorphism to the character φ^{λ} of the permutation module on the cosets of the Young subgroup $S_{\lambda_1} \times \dots \times S_{\lambda_n}$ [10]I.7; we call the φ^{λ} Young characters. Moreover, the Schur function s_{λ} corresponds to the irreducible character χ^{λ} of S_d [10] I(7.5).

3.1.1 The observation in 2.3.1 shows that $I_{br}(R)$ contains $\psi^r(R^d)$ for $d \ge 1$, and then as well $\psi^r(R^d)R$. Hence $I_{br}(\Lambda)$ contains $\psi^r(\Lambda^d)\Lambda$, for $d \ge 1$.

3.2 First we give a \mathbb{Z} -basis of $I_{br}(\Lambda)$ in terms of the symmetric functions h_{λ} .

Theorem Let $r \ge 1$. Then Λ has \mathbb{Z} -basis

 $\mathcal{H}_r := \{ \psi^r(h_{\lambda}) \cdot h_{\mu} : \lambda, \mu \text{ partitions with } \mu \text{ r-regular } \}.$

Moreover if r > 1 then $I_{br}(\Lambda)$ has \mathbb{Z} -basis $\mathcal{H}^0_r := \{\psi^r(h_\lambda) \cdot h_\mu \in \mathcal{H}_r : \lambda \neq \emptyset\}.$

We remark that \mathcal{H}_1 is one of the usual bases for Λ [10] I(2.8). For the proof we will use the following.

3.3 Suppose γ is a partition such that h_{γ} occurs with non-zero coefficient in $\psi^r(h_{\lambda}) \cdot h_{\mu}$, then $\gamma \geq \lambda^r \cup \mu$.

Proof By the hypothesis there are partitions $\tau^{(i)}$ such that $h_{\tau^{(i)}}$ occurs in $\psi^r(h_{\lambda_i})$ and $\gamma = \tau^{(1)} \cup \tau^{(2)} \cup \cdots \cup \tau^{(l(\lambda))} \cup \mu$. Then $|\tau^{(i)}| = r|\lambda_i|$ and $\tau^{(i)}$ has at most r parts. Now, (λ_i^r) is the least partition of $r|\lambda_i|$ with at most r parts, so $\tau^{(i)} \ge (\lambda_i^r)$ for each i. So we must show the following.

If $\tau^{(i)}$, $\delta^{(i)}$ are partitions with $\tau^{(i)} \ge \delta^{(i)}$ and $|\tau^{(i)}| = |\delta^{(i)}|$ for all i then $\tau^{(1)} \cup \tau^{(2)} \cup \cdots \cup \tau^{(m)} \ge \delta^{(1)} \cup \delta^{(2)} \cup \cdots \cup \delta^{(m)}$.

Let c_1 be the first part of $\tau^{(1)} \cup \tau^{(2)} \cup \cdots \cup \tau^{(m)}$. Then $c_1 \ge (\tau^{(i)})_1$ for each *i*, and so $c_1 \ge (\delta^{(i)})_1$ for each *i*. If c_1 is greater than the first part of $\delta^{(1)} \cup \delta^{(2)} \cup \cdots \cup \delta^{(m)}$ then we are done. Otherwise, there is some *j* with $(\delta^{(j)})_1 = c_1$, and then $(\tau^{(j)})_1 = c_1$ as well. Remove the first part from $\tau^{(j)}$ and from $\delta^{(j)}$. The induction hypothesis gives the statement.

3.4 We will now prove 3.2, by considering $\mathcal{H}_r \cap \Lambda^d$ for a fixed degree *d*. We know that Λ^d has a \mathbb{Z} -basis contained in \mathcal{H}_1 ; and so it suffices to show that, the coefficient matrix $M(\mathcal{H}_r, \mathcal{H}_1)$ is lower triangular, with diagonal entries ± 1 . To do so, we label the symmetric function $\psi^r(h_\lambda) \cdot h_\mu$ by the partition $\lambda^r \cup \mu$; and we order these lexicographically.

If h_{γ} occurs in $\psi^r(h_{\lambda}) \cdot h_{\mu}$ then $\gamma \geq \lambda^r \cup \mu$; this follows from 3.3. Hence the coefficient matrix is lower triangular. Moreover, if $\gamma = \lambda^r \cup \mu$ then $\tau^{(i)} = (\lambda_i^r)$ and it follows that the coefficient of h_{γ} in $\psi^r(h_{\lambda})h_{\mu}$ is equal to ± 1 , by 2.5.1. Note also that the rank of Λ^d is the same as the number of elements in $\mathcal{H}_r \cap \Lambda^d$. Hence we are done with the first part.

Consider the second part, by 3.1.1 we know that $\mathcal{H}_r^0 \cap \Lambda^d$ is contained in $I_{br}(\Lambda^d)$, and by the first part it is \mathbb{Z} -linearly independent. We know that the image of ξ is free over \mathbb{Z} of rank equal to the number of *r*-regular partitions of *d*. Hence the kernel of ξ has rank equal to the size of $\mathcal{H}_r^0 \cap \Lambda^d$, and this implies that $\mathcal{H}_r^0 \cap \Lambda^d$ is a \mathbb{Z} -basis for $I_{br}(\Lambda^d)$.

3.5 Theorem Let $r \ge 1$. Then Λ has \mathbb{Z} -basis

 $\Sigma_r := \{ \psi^r(s_{\lambda}) \cdot s_{\mu} : \lambda, \mu \text{ partitions with } \mu \text{ r-regular } \}.$

Moreover if r > 1 then $I_{br}(\Lambda)$ has \mathbb{Z} -basis { $\psi^r(s_{\lambda}) \cdot s_{\mu} \in \Sigma_r : \lambda \neq \emptyset$ }.

Proof We consider $\Sigma_r \cap \Lambda^d$ for a fixed degree *d*. For the first part, we will show that the coefficient matrix $M(\Sigma_r, \mathcal{H}_r)$ is lower triangular, with diagonal entries ± 1 . We label $\psi^r(s_\lambda) \cdot s_\mu$ and also $\psi^r(h_\lambda) \cdot h_\mu$ by the partition associated to $\lambda^r \cup \mu$, and we order these lexicographically, as before.

Consider $\psi^r(s_\lambda) \cdot s_\mu$. Express s_λ in terms of the h_γ ; the transition matrix is $M(s, h) = K^*$, in the notation of [10] I(6.3), and it is strictly lower unitriangular. Express also s_μ in terms of the basis \mathcal{H}_r , the transition matrix is the product of M(s, h)

and $M(\mathcal{H}_1, \mathcal{H}_r)$, so by [10] I(6.3) and 2.4 it is lower triangular, with diagonal entries ± 1 . We get

(*)
$$\psi^r(s_{\lambda}) \cdot s_{\mu} = (\sum_{\lambda \le \gamma} K^*_{\lambda \gamma} \psi^r(h_{\gamma})) \cdot (\sum b_{\mu, \beta^r \cup \alpha} \psi^r(h_{\beta}) \cdot h_{\alpha})$$

the second sum is taken over all α , β such that $\mu \leq \beta^r \cup \alpha$ and α is *r*-regular. Replacing $\psi^r(h_{\gamma}) \cdot \psi^r(h_{\beta})$ by $\psi^r(h_{\gamma \cup \beta})$ and re-arranging gives the expression of $\psi^r(s_{\lambda}) \cdot s_{\mu}$ in terms of the basis \mathcal{H}_r . We are done if we show that the coefficient matrix is unitriangular with ± 1 's in the diagonal.

We claim that the coefficient of $\psi^r(h_\lambda) \cdot h_\mu$ in this expression is ± 1 . The coefficient is equal to $\sum K^*_{\lambda\gamma} b_{\mu,\beta^r \cup \mu}$ where the sum is taken over all γ, β such that $\lambda \leq \gamma$, $\mu \leq \beta^r \cup \mu$ and $\gamma \cup \beta = \lambda$ These conditions imply $\beta = \emptyset$ and $\lambda = \gamma$, so there is only one term and it is ± 1 .

Suppose the coefficient of $\psi^r(h_{\sigma}) \cdot h_{\alpha}$ is non-zero, for α *r*-regular. We must show that then $\lambda^r \cup \mu \leq \sigma^r \cup \alpha$. The coefficient is equal to

$$\sum K^*_{\lambda\gamma} b_{\mu,\beta^r\cup\alpha}$$

where the sum is taken over all γ , β with $\gamma \cup \beta = \sigma$, $\lambda \leq \gamma$ and $\mu \leq \beta^r \cup \alpha$. Then $\lambda^r \leq \gamma^r$, hence we deduce

$$\lambda^{r} \cup \mu \leq \gamma^{r} \cup \mu \leq \gamma^{r} \cup \beta^{r} \cup \alpha = (\gamma \cup \beta)^{r} \cup \alpha = \sigma^{r} \cup \alpha.$$

The rest follows by the same argument as the second part of 3.4.

3.6 Corollary Let $r \ge 1$. Then R has \mathbb{Z} -bases

$$\mathcal{H}_r := \{ \psi^r(\eta_{\lambda}) \cdot \eta_{\mu} : \lambda, \mu \text{ partitions and } \mu \text{ r-regular} \}$$
$$\Sigma_r := \{ \psi^r(\chi^{\lambda}) \cdot \chi^{\mu} : \lambda, \mu \text{ partitions and } \mu \text{ r-regular} \}.$$

Moreover $I_{br}(R)$ has \mathbb{Z} -bases

$$\mathcal{H}_r^0 := \{ \psi^r(\eta_\lambda) \cdot \eta_\mu \in \mathcal{H}_r : \lambda \neq \emptyset \} \text{ and } \Sigma_r^0 := \{ \psi^r(\chi^\lambda) \cdot \chi^\mu \in \Sigma_r : \lambda \neq \emptyset \}$$

This follows from 3.2 and 3.5.

4 Some presentations and relations

4.1 The basis elements of degree d in \mathcal{H}_r , or Σ_r respectively describe a complete minimal set of relations for $I_{br}(\Lambda^d)$ or equivalently for $I_{br}(R^d)$. The ring R_{br} is isomorphic to Λ/I where $I = I_{br}(\Lambda)$. The results 3.2 and 3.5 show that I is generated by $\psi^r(\Lambda^+)$ where $\Lambda^+ = \bigoplus_{d>1} \Lambda^d$. Hence we get from 2.4 the presentation

$$R_{br} \cong \mathbb{Z}[h_1, h_1, \ldots] / \langle \sum_{\alpha \in \Lambda^+(r, rs)} m_\alpha(z) h_\alpha, \ s = 1, 2, \ldots \rangle.$$

An explicit description of the ideal *I* can be found in [5] 4.4.

4.2 Assume now r = p, we consider the ring R_{br} modulo p. We deduce the following, which is a special case of [6] 4.7, Remark 3.

Corollary Let *F* be a field of characteristic *p*. Then the ring $R_{br} \otimes_Z F$ is isomorphic to

 $F[h_1, h_2, \ldots]/\langle h_s^p, s = 1, 2, \ldots \rangle$

where the h_i are algebraically independent variables.

Proof For each $d \ge 1$ we have an exact sequence of \mathbb{Z} -modules

$$0 \to I_{br}(\Lambda^d) \to \Lambda^d \to \Lambda^d_{br} \to 0$$

By 2.2 this is a split exact sequence of free \mathbb{Z} -modules. We deduce that $R_{br}^d \otimes F \cong (\Lambda^d \otimes F)/(I_{br}(\Lambda^d) \otimes F)$, (writing $\otimes = \otimes_{\mathbb{Z}}$) and

$$R_{br} \otimes F \cong \bigoplus_{d \ge 0} (\Lambda^d \otimes F) / (I_{br}(\Lambda^d) \otimes F) \cong (\Lambda \otimes F) / (I_{br}(\Lambda) \otimes F).$$

Moreover $\Lambda \otimes F$ is the free polynomial ring in the independent variables $h_s \otimes 1$. We claim now that $I_{br}(\Lambda) \otimes F$ is equal to the ideal of $\Lambda \otimes F$ generated by $(h_s \otimes 1)^p$, s = 1, 2, This holds because $I_{br}(\Lambda)$ is generated by the $\psi^p(h_s)$, and by 2.5 we have over characteristic p that

$$\psi^p(h_s) \otimes 1 = (-1)^{(p-1)s} h_{(s^p)} \otimes 1 = h_s^p \otimes 1. \qquad \Box$$

4.3 We can also exploit the basis in 3.5. Since the Schur functions form a \mathbb{Z} -basis of Λ , there are integers b_{γ} such that $\psi^r(s_{\lambda}) = \sum_{\gamma} b_{\gamma} s_{\gamma}$. Then we have by 2.3.2 that

$$b_{\gamma} = (\psi^r(s_{\lambda}), s_{\gamma}) = (s_{\lambda}, \psi_r(s_{\gamma})).$$

Now, $\psi_r(s_{\gamma})$ has been determined by G. Walker; he proved the following [17] 2.3.

Theorem Suppose γ has empty r-core. Then we have

$$\psi_r(s_{\gamma}) = \sigma_r(\gamma) \cdot \prod_{k=0}^{r-1} s_{\gamma(k)}$$

Here $\gamma(0), \dots, \gamma(r-1)$ are the r-quotients of γ . Otherwise $\psi_r(s_{\gamma}) = 0$.

We deduce $b_{\gamma} = 0$ unless $\gamma \sim_r \emptyset$. In this case, $b_{\gamma} = \sigma_r(\gamma) L R^{\lambda}_{\gamma(0), \dots, \gamma(r-1)}$ where $L R^{\lambda}_{\tau(0), \dots, \tau(m)}$ is the coefficient of s_{λ} in the product $s_{\tau(0)} \cdot s_{\tau(1)} \cdots s_{\tau(m)}$. It follows

that

$$\psi^{r}(s_{\lambda}) \cdot s_{\mu} = \sum_{|\alpha|=d} \left(\sum_{\gamma \sim r^{\emptyset}} \sigma_{r}(\gamma) L R^{\lambda}_{\gamma(0), \cdots, \gamma(r-1)} \cdot L R^{\alpha}_{\gamma, \mu} \right) s_{\alpha}$$

A similar formula was obtained in [1].

4.4 Assume now that r = p, a prime. Consider the relations $\psi^r(\varphi^{\lambda}) \cdot \varphi^{\mu}$ with μ *p*-regular, and $\lambda \neq \emptyset$ for the symmetric groups. Recall that we use the partition $\gamma = \lambda^p \cup \mu$ as a label, this is *p*-singular and every *p*-singular partition has a unique expression of this form. We deduce from 3.6:

Corollary For every p-singular partition γ , there is a generalized character $\sum a_{\beta}\varphi^{\beta}$ with $a_{\beta} \in \mathbb{Z}$, unique up to scalar multiples which vanishes on p-regular elements such that $a_{\gamma} \neq 0$ and moreover $a_{\beta} \neq 0$ implies $\gamma \leq \beta$.

There is also a block version for such class function.

5 Connection with the Solomon descent algebra

5.1 Let *d* be a positive integer. We recall some properties of the Solomon descent algebra of the symmetric group S_d (details can be found in [12], [4], [13], [2], [3], [16]). Let μ be a composition of *d*, and let S_{μ} be the associated Young subgroup of S_d . Each right coset of S_{μ} in S_d contains a unique permutation of minimal length (see for example [16, Lemma 1]). Define X^{μ} to be the sum in the integral group ring $\mathbb{Z}S_d$ of all these minimal coset representatives. Solomon [16, Theorem 1] proved that the \mathbb{Z} -linear span \mathcal{D}_d of the elements X^{μ} (μ any composition of *d*), is a subring of $\mathbb{Z}S_d$, which is now called the Solomon descent algebra of S_d . In fact, he showed that the multiplication constants with respect to the basis of the X^{μ} are precisely the multiplication constants for the Young characters. Denote for the moment by C_d the \mathbb{Z} -span of the Young character induced from the trivial character of S_{μ} , then the \mathbb{Z} -linear map $c_d : \mathcal{D}_d \to C_d$ which takes

$$X^{\mu} \longmapsto \varphi^{\mu}$$

for compositions μ of d, is a surjective ring homomorphism.

Let *F* be a field, then the *F*-linear span $\mathcal{D}_{d,F}$ of the elements X^{μ} is a subalgebra of the group algebra FS_d , while the *F*-linear span $\mathcal{C}_{d,F}$ of the *F*-valued Young characters

$$\varphi^{\mu,F}: \mathcal{S}_d \to F, \pi \mapsto \varphi^{\mu}(\pi) \cdot 1_F$$

is a subalgebra of the algebra of *F*-valued class functions of S_d . The *F*-linear map $c_{d,F} : \mathcal{D}_{d,F} \to \mathcal{C}_{d,F}$ taking X^{μ} to $\varphi^{\mu,F}$ for compositions μ of *d*, is an epimorphism of algebras. Moreover,

Theorem The kernel of $c_{d,F}$ is the radical of $\mathcal{D}_{d,F}$.

This is [16] Theorem 3 for characteristic zero, and it is [2] Theorem 2 for prime characteristic. Hence $C_{d,F}$ is isomorphic to the radical quotient $\mathcal{D}_{d,F}/\operatorname{rad}\mathcal{D}_{d,F}$.

5.2 We will relate this to the decomposition map. First, we give a different basis for R_{br}^d . We know that R_{br}^d has free \mathbb{Z} -basis the $\xi(\chi^{\lambda})$ for λ p-regular. Let φ^{λ} be the Young character associated to λ and let φ_0^{λ} be its restriction to *p*-regular elements (that is the image of φ^{λ} under the decomposition map).

Lemma The set $\mathcal{B} := \{\varphi_0^{\lambda} : \lambda a \text{ p-regular partition of } d\}$ is a \mathbb{Z} -basis for R_{hr}^d .

This holds because the coefficient matrix obtained by expressing φ^{λ} in terms of χ^{μ} is lower unitriangular.

We work now with the \mathbb{Z} -bases of R^d and R_{br}^d given by φ^{λ} and the φ_0^{λ} respectively. We view R^d as a ring with respect to the multiplication of characters. The decomposition map ξ is then a ring homomorphism and hence I_{br}^d is an ideal of R^d .

Theorem 1 Assume *F* has characteristic *p*. Then $R_{br}^d \otimes_{\mathbb{Z}} F$ is isomorphic to the radical quotient $C_{d,F}$ of the Solomon descent algebra $\mathcal{D}_{d,F}$.

Proof The ring \mathbb{R}^d is the same as \mathcal{C}_d . We have therefore two surjective *F*-algebra maps starting at $\mathcal{C}_d \otimes F$. One is the map which takes $\varphi^{\lambda} \otimes 1$ to $\varphi^{\lambda,F}$, call the map ρ . The other is $\xi \otimes 1$. Furthermore, the images of these, that is $\mathcal{C}_{d,F}$ and $\mathbb{R}^d_{br} \otimes F$ are *F*-vector spaces of the same dimension. So it is enough to show that ρ maps the $I_{br} \otimes F$, that is the kernel of $\xi \otimes 1$, to zero. This will induce a surjection from $\mathbb{R}^d_{br} \otimes F$ onto $\mathcal{C}_{d,F}$, which must be an isomorphism, by dimensions.

We use the basis from 3.6. It suffices to show that any $\psi^p(\varphi^\lambda)\varphi^\mu$ with $\lambda \neq \emptyset$ (and of the right degree $d = p|\lambda| + |\mu|$) lies in the kernel of ρ , that is, all its values are divisible by p.

We have seen in 2.3.1 that the class function $\chi_1 := \psi^p(\varphi^\lambda)$ is supported on fixed point free elements for which all cycles have lengths divisible by *p*. Let $\chi_2 = \phi^\mu$, then

$$\chi_1 \chi_2 = \operatorname{Ind}_H^G(\chi_1 \otimes \chi_2)$$

where $H = S_{mp} \times S_t$ with $m = |\lambda|$ and $t = |\mu|$. Let $\eta = \chi_1 \otimes \chi_2$; then $\text{Ind}_H^G(\eta)(g) = \sum_{i=1}^{m} \dot{\eta}(g_i g g_i^{-1})$ where $\{g_1, \ldots, g_m\}$ are coset representatives of H in G and where

$$\dot{\eta}(g) = \begin{cases} \eta(g) \ g \in H \\ 0 \quad \text{otherwise} \end{cases}$$

Suppose $\dot{\eta}(y^{-1}gy)$ is non-zero. Then $y^{-1}gy = g_1g_2$ with $g_1 \in S_{mp}$ and $g_2 \in S_t$. Furthermore, g_1 has cycle type $p\gamma \neq \emptyset$, and we have $\dot{\eta}(g_1g_2) = \chi_1(g_1)\chi_2(g_2)$. By 2.3.1, the character value $\chi_1(g_1)$ is divisible by p, and since $\chi_2(g_2)$ is an integer we deduce that $\text{Ind}_H^G(\eta)(g)$ is divisible by p as required.

Corollary The radical quotient of the *F*-algebra $\mathbb{R}^d \otimes_{\mathbb{Z}} F$ is isomorphic to the radical quotient of the Solomon descent algebra $\mathcal{D}_{d,F}$.

Given an algebra which is not semisimple, then it is a basic problem to understand the algebra modulo the square of its radical, that is to understand its Ext quiver.

Manfred Schocker worked on finding the Ext quiver of descent algebras. Some examples are given in [13]. When F has characteristic zero, he gives a complete answer in [14] and in fact the algebras he studies there are more general. He writes that the quiver for non-zero characteristic is not yet understood. The connection with the decomposition map should be an additional reason why the quiver is interesting, and also perhaps give a different kind of information.
