# Volume change under drilling

#### **Abstract**

Given a hyperbolic  $3\{\text{manifold }M\text{ containing an embedded closed geodesic, we estimate the volume of a complete hyperbolic metric on the complement of the geodesic in terms of the geometry of <math>M$ . As a corollary, we show that the smallest volume orientable hyperbolic  $3\{\text{manifold has volume }>:32.$

#### 1 Introduction

showed that given a hyperbolic  $3\{\text{manifold }M\text{ and an embedded }\}$ geodesic M, the manifold M – M has a metric of negative sectional curvature [11], using a method of Gromov and Thurston [2]. Therefore by Thurston, M admits a unique complete hyperbolic metric, ie, a metric of constant sectional curvature -1 [13]. In theorem 2.1 of this paper, we has an embedded tubular neighborhood of radius R, then show that if  $(\coth R)^{\frac{5}{2}}(\coth 2R)^{\frac{1}{2}} \operatorname{Vol}(M)$ , where Vol denotes the volume of the Vol(M)unique complete hyperbolic structure. Speci cally, we use Kerckho 's method to ll in a metric on M in order to apply a theorem of Boland, Connell, and Souto [3], which is based on an important technique of Besson, Courtois, and Gallot [1], to get an upper bound on the hyperbolic volume of M in terms of the geometry of M. As a corollary, we show that the smallest volume orientable hyperbolic 3{manifold has volume > :32. It is conjectured that the Weeks manifold, which has volume = .9427:::, is the smallest volume hyperbolic 3{manifold. This is known to be the smallest volume arithmetic hyperbolic 3{manifold, by a result of Chinburg, Friedmann, Jones, and Reid [6]. The smallest volume orientable cusped manifolds are known to be the gure eight knot complement and its sibling, which have volume = 2.0298..., by a result of Cao and Meyerho [5], which we use combined with the main theorem to obtain our lower bound.

#### 2 Estimates

**Theorem 2.1** Let M be an orientable hyperbolic  $3\{\text{manifold with metric} : Let M \text{ be a geodesic in } M \text{ of length } I \text{ with an embedded open tubular neighborhood } C \text{ of radius } R, \text{ and with complete hyperbolic metric} \text{ on } M \text{ .}$

**Remark** This theorem can be easily generalized to a geodesic link in M with an embedded tubular neighborhood, but we restrict to the case of one component to simplify the argument, since this is the context of our main application. Also, if M is non-orientable, then we may apply this theorem to the  $2\{\text{fold orientable covering to recover the same estimate.}\}$ 

The intuition behind the estimate is that we construct a Riemannian metric on M which coincides with the metric on MnC, such that Ric -2k, where  $k = \coth R \coth 2R$ . Then we would like to apply the following Volume Theorem of Boland, Connell and Souto to compare the two metrics on M:

**Theorem 2.2** [3] Let (M;g) and  $(M_0;g_0)$  be two oriented complete nite volume Riemannian manifolds of the same dimension 3, and suppose that  $Ric_g - (n-1)g$ , and -a  $K_{g_0} - 1$ . Then for all proper continuous maps  $f: M! M_0$ ,

and equality holds if and only if f is proper homotopic to a Riemannian covering.

In our situation, we want to choose  $(M_0; g_0) = (M; )$ , where K = -1, since the metric is hyperbolic, (M; g) = (M; k), where we scale by k so that it satis es  $Ric_k -2k$  almost everywhere, and  $f = Id_M$  is degree one and proper. Then we would like to apply theorem 2.2 to conclude that Vol(M; k) - Vol(M; ), which may be computed to obtain the estimate of theorem 2.1. Some technicalities are involved in that the metric we construct is only  $C^1$ , so that we must approximate by smooth metrics in order to apply theorem 2.2.

**Proof of theorem 2.1** The tubular neighborhood C of radius R of length I has a metric in cylindrical coordinates  $(r; \cdot; \cdot)$  given by  $ds^2 = dr^2 + \sinh^2 rd^{-2} + \cosh^2 rd^{-2}$ , on the cylinder C = [0; R] - [0; 2] - [0; I] with  $(r; 0; \cdot) - (r; 2; \cdot)$ ,  $(r; \cdot; 0) - (r; + \cdot; I)$  and  $(0; \cdot; \cdot) - (0; 0; \cdot)$ , for some constant giving the rotational part of the holonomy of C and C may be obtained from C by removing C from C and replacing it with the region  $C^0 = (-1; R) - [0; 2] - [0; I]$ , with the same rst two identications as above. We will give  $C^0$  a metric of the form  $ds^2 = dr^2 + f(r)^2 d^2 + g(r)^2 d^2$ . These types of metrics were considered by Gromov and Thurston in proving their 2 {theorem for obtaining negatively curved metrics on Dehn lled 3{manifolds [2]. We need to compute sectional curvatures for this metric. This has been done by Bleiler and Hodgson [2], but we will give a sketch of a derivation as explained to us by Thurston.

**Lemma 2.3** The metric  $dr^2 + f(r)^2 d^2 + g(r)^2 d^2$  on  $\mathbb{R}^3$  has sectional curvatures

$$K = -\frac{f^{\theta}g^{\theta}}{fg}; K_r = -\frac{f^{\theta\theta}}{f}; K_r = -\frac{g^{\theta\theta}}{g}$$

**Proof** First we will compute K. Fix a reference point  $(r_0; 0; 0)$  at which to compute the curvature. Consider the plane  $H = (r_0; ; )$ . H is isometric to the euclidean plane, so the Gauss curvature of H is 0. The reflection through the plane = 0 preserves H and  $(r_0; 0; 0)$ , so the lines of principal curvature of H at  $(r_0; 0; 0)$  are invariant under this reflection. Thus, they must be parallel to the vectors  $\frac{@}{@}$  and  $\frac{@}{@}$ . To compute the principal curvatures, we can compute the geodesic curvatures of H {geodesics in the and directions. Consider the curve  $C = (r_0; ; 0)$ . The length of C on the interval [0, 0, 0, 0] is [0, 0, 0, 0]. Since the reflection in the plane [0, 0, 0, 0] preserves C, the osculating plane of C must be the plane [0, 0, 0, 0] so that the normal variation lies in this osculating plane. The geodesic curvature is then the logarithmic derivative of the length of the variation (compare to the euclidean case),  $K_g = \frac{@}{@F} \log(2 f(r)) = \frac{f^0}{F}$ , which gives the principal curvature of C in the direction of C. Kerckho 's proof that M has a metric of negative sectional curvature follows from lemma 2.3 by noting that one may choose  $C^1$  functions f(r) and g(r) on (-1;R] such that for r near R,  $f(r) = \sinh r$  and  $g(r) = \cosh r$ , and such

that all of f(r);  $f^{\emptyset}(r)$ ;  $f^{\emptyset}(r)$ ; g(r);  $g^{\emptyset}(r)$ ;  $g^{\emptyset}(r)$  are > 0 (see gure 1). Then it follows that M is atoroidal, anannular, and irreducible, so M has a complete hyperbolic metric—of—nite volume by Thurston's hyperbolization theorem of Haken manifolds [13].




Figure 1: Constructing a negatively curved metric

We want to construct metrics on M for which we may apply theorem 2.2. Let  $f(r) = (\sinh R) e^{(\coth R)(r-R)}$ , and  $g(r) = (\cosh R) e^{(\tanh R)(r-R)}$ . This gives a  $C^1$  metric on  $C^{\ell}$ , which induces a  $C^1$  metric on M, where agrees with on M  $nC^{\ell} = MnC$ .

On  $C^{\emptyset}$ , choose the orthonormal basis for the tangent space at a xed point  $(e_1;e_2;e_3)=(\frac{@}{@r};\frac{1}{f}\frac{@}{@r};\frac{1}{g}\frac{@}{@r})$ . The reflections ! – and ! – preserve the metric locally, so must preserve the maximal and minimal sectional curvatures. The only tangent planes preserved by both these reflections are spanned by  $fe_i;e_jg$ ,  $i \not\in j$ . Thus, we conclude that the sectional curvatures  $K_r=K_{e_1e_2}$ ,  $K=K_{e_2e_3}$ , and  $K_r=K_{e_1e_3}$  realize the minimum and maximum sectional curvatures. It is well known that in such coordinates, the Ricci curvature is diagonalized. To see this, one computes the curvature tensor  $R(e_i;e_j;e_k;e_l)$  (see [9], ch. III A, for notational conventions). The sectional curvature of the plane spanned by  $fe_i;e_jg$  is  $R(e_i;e_j;e_i;e_j)$ . If this sectional curvature is maximal, then we see that

Similarly, one may see that  $R(e_j;e_k;e_j;e_i) = R(e_k;e_i;e_k;e_j) = 0$ , by exchanging the roles of i and j, and using the same observation for the minimal sectional curvature. So all the o-diagonal terms of R vanish. Since Ric  $(e_i;e_j) = \frac{3}{k=1} R(e_k;e_i;e_k;e_j) = 0$ , if  $i \neq j$  we see that the o-diagonal terms of the Ricci tensor vanish as well. We compute Ric in the basis  $(e_1;e_2;e_3)$ :

$$Ric = {4 \choose 4} {K_r + K_r} & 0 & 0 & 5$$

by lemma 2.3. We have

where the last inequality uses the fact that  $/\sinh^2 R = \text{Vol}(C_c^*)$   $\text{Vol}(M_c^*)$ .

**Lemma 2.4** There is a family of negatively curved metrics on M such that Vol(M; )! Vol(M; ) and Ric = -2k, where k! coth Rcoth 2R as  $! 0^+$ .

Using this lemma, we can nish the proof of theorem 2.1. Consider the family of metrics on M. The metrics k on M satisfy  $Ric_k = Ric -2k$ . Given this Ricci curvature control, we can apply theorem 2.2 with (M;g) = (M; ),  $(M_0; g_0) = (M; k_e)$ , and  $f = Id_M$  to conclude that

**Proof of lemma 2.4** We will construct the metric by smoothing on the region  $C^{\ell}$ , by smoothing the functions f(r) and g(r) using the construction given in the following lemma.

**Proof of lemma 2.5** The idea is to smoothly interpolate between the functions b(r) and c(r). If we were to just use a partition of unity to interpolate between them, we would not control the rst and second derivatives of the interpolation. So instead, we use a partition of unity to interpolate between  $b^{\emptyset}(r)$  and  $c^{\emptyset}(r)$  to get a function  ${}^{\emptyset}(r)$ . Integrating twice, we must add bump functions in order to get the correct properties.

De ne

$$(r) = \begin{cases} e^{-1-r^2} e^{-1-(1-r)^2} & 0 < r < 1; \\ 0 & r = 0; r = 1. \end{cases}$$

Then (r) is a  $C^1$  bump function. Let  $(r) = {R \choose r} (t) dt = {R \choose 0} (t) dt$ . Then  ${\ell \choose r} = 0$ , and  ${\ell \choose r} = 0$  is supported on [0;1]. Let (r) = ((r-R)=+1), if >0, and  ${\ell \choose 0} = 0$ . Let  ${\ell \choose r} = b^{\ell \ell \choose 0} (1-(r))+c^{\ell \ell \choose 0} (r)$  ( $r \choose 0 = 2(a)$ ). Then  ${\ell \choose 0} = b^{\ell \ell \choose 0} (r)$  for  $r \choose 0 = 0$ , and  ${\ell \choose 0} = c^{\ell \ell \choose 0} (r)$  for  $r \choose 0 = 0$ , and thus  ${\ell \choose 0} = 0$  interpolates between  $b^{\ell \ell \choose 0} = 0$  and  $c^{\ell \ell \choose 0} = 0$ . 


Figure 2: Interpolating between  $b^{\emptyset}$  and  $c^{\emptyset}$ 

Continuing with the proof of lemma 2.4, one may see by integrating that under the conditions of lemma 2.5, we have a(r) ! a(r) and  $a^{\ell}(r) ! a^{\ell}(r)$  uniformly as  $! 0^+$  (gure 3). For the functions f(r) and g(r) de ning , we can use lemma 2.5 to construct a sequence of functions f(r) and g(r) such that  $f^{\ell}(r) ! f^{\ell}(r)$ , f(r) ! f(r) as  $! 0^+$ , and  $\lim_{l \to \infty} \sup_{r \to \infty} f^{\ell}(r) = f^{\ell}(r)$ . Similarly  $g^{\ell}(r) ! g^{\ell}(r)$ , g(r) ! g(r) and  $\lim_{l \to \infty} \sup_{r \to \infty} g^{\ell}(r) = \cosh(R)$ , where () comes from the construction in lemma 2.5. Moreover, for small enough,  $g^{\ell}(r)$  and  $f^{\ell}(r) > 0$  for all r, so that is negatively curved for small (gure 2(b)). One may use these properties to show that  $\sup_{r \to \infty} f^{\ell}(r) = f(r) ! \cosh^2 R$ ,  $\sup_{r \to \infty} g^{\ell}(r) = g(r) ! 1$ , and  $\sup_{r \to \infty} f^{\ell}(r) g^{\ell}(r) = (f(r)g(r)) ! 1$  as  $e^{\ell}(r) = (f(r)g(r)) ! 1$ . From this, we deduce that  $\lim_{r \to \infty} f^{\ell}(r) = (f(r)g(r)) ! 1$ .




Figure 3: Smoothing  $a^{0}$  and a

# 3 Applications

First, we state a theorem of Gabai, Meyerho, and Thurston.

**Theorem 3.1** [8, 4.11] Let be a minimal length geodesic in a closed orientable hyperbolic  $3\{\text{manifold }M,\text{ of length }l\text{ and tube radius }R.$  Either

- (1)  $R > (\ln 3) = 2$ , or
- (2) 1.0953=2 > R > 1.0591=2 and l > 1.059, or
- (3) R = .8314:::=2 and M = Vol3, the closed manifold of third smallest volume in the Snappea census [17], which has volume = 1:0149:::.

The following corollary is of interest in controlling the geometry of a minimal volume hyperbolic 3{manifold. This improves on the estimate of theorem 1.1 of Gabai, Meyerho , and Milley in [7], and theorem 4.7 of Przeworski [14]. This estimate may be useful in a computational approach to  $\,$  nd the minimal volume orientable hyperbolic 3{manifold proposed by Gabai, Meyerho , and Milley [7] by extending the computations and method of [8].

**Corollary 3.2** The minimal volume orientable hyperbolic  $3\{\text{manifold }M\text{ has }Vol(M) > :32, \text{ and the minimal length geodesic} \quad \text{in }M\text{ has tube radius }R < :956.$ 

**Proof** We may assume that M is closed, since if M had a cusp, then by Cao and Meyerho 's result that a cusped oriented manifold has volume > 2.0298 [5], which is greater than the volume of the Weeks manifold, M would not have

minimal volume. We may assume that  $R > (\ln 3) = 2$ , since in cases 2 and 3 of theorem 3.1, the volume is > 1.01, which is greater than the volume of the Weeks manifold, as observed in [8].

By a result of Cao and Meyerho [5],  $Vol(\mathcal{M}) > 2.0298$ . Then by theorem 2.1, we have  $Vol(\mathcal{M}) > Vol(\mathcal{M}) = (\coth^{\frac{5}{2}}(\ln 3 = 2) \coth^{\frac{1}{2}}(\ln 3)) > .32$ .

We also have

2.0298 < Vol(M)  $(\coth R)^{\frac{5}{2}}(\coth 2R)^{\frac{1}{2}}\text{Vol}(M) < (\coth R)^{\frac{5}{2}}(\coth 2R)^{\frac{1}{2}}.943$ :

Thus, we get the upper bound  $R < R_0 < .956$ , where

$$2.0298 = (\coth R_0)^{\frac{5}{2}} (\coth 2R_0)^{\frac{1}{2}} :943$$




Figure 4: Bridgeman's conjecture for drilling geodesics in Weeks' manifold

**Remark** Przeworski has used theorem 2.1 and a result of Marshall and Martin [12] to show that the minimal length geodesic in a 3{manifold of minimal




Figure 5: Log plot of the estimate for drilling geodesics in Weeks' manifold

volume is :184 and has tube radius R < :946 (Proposition 7.4 [15]). Przeworski points out that this estimate could be improved slightly. He has also used theorem 2.1 and some packing arguments to improve the lower bound in theorem 3.2 to :3315 (Proposition 5.4, [16]).

It would be interesting to understand exactly how much the volume can increase when one drills out a geodesic. Bridgeman has conjectured [4] that if one drills an embedded geodesic of length I out of I, then I volI volI volI volI Hardening Bridgeman proved this for many special examples. We have used Oliver Goodman's program I tube [10] to give computational evidence that this conjecture is false in general. Figure 4 gives data obtained from I tube, by drilling many of the shortest geodesics from the Weeks manifold. There appear to be ve cases where Bridgeman's conjecture fails. The estimate given in theorem 2.1 is not at all close to being sharp, especially when I is small, see gure 5.
