Units of ring spectra and their traces in algebraic K-theory

Abstract

Let $GL_1(R)$ be the units of a commutative ring spectrum R. In this paper we identify the composition

 $_{R}$: BGL₁(R) ! K(R) ! THH(R) ! ¹(R);

where K(R) is the algebraic K-theory and THH(R) the topological Hochschild homology of R. As a corollary we show that classes in $_{i-1}R$ not annihilated by the stable Hopf map $2 {}_{1}^{S}(S^{0})$ give rise to non-trivial classes in $K_{i}(R)$ for $i \quad 3$.

1 Introduction

Given a connective (symmetric) ring spectrum R, we follow Waldhausen and de ne the units $GL_1(R)$ to be the union of the components in ${}^1(R)$ that correspond to units in the discrete ring ${}_0R$. With this de nition $GL_1(R)$ is a group-like monoid whose group of components equals $GL_1({}_0R)$. As in the case of a discrete ring there is a natural map $BGL_1(R)$! K(R) to the algebraic K-theory of R. If R is a commutative discrete ring this is split by the determinant, but the de nition of the determinant does not generalize to the setting of ring spectra and the above map is in general not split, even if R is commutative. For example, Waldhausen shows [21] that this fails quite badly for the sphere spectrum. However, it turns out that the notion of traces of matrices does generalize to ring spectra. This gives rise to the trace map tr: K(R) ! THH(R), where the target is the topological Hochschild homology rst de ned by Bökstedt [6]. The purpose of the present paper is to identify the composition

$$_{R}: BGL_{1}(R) ! K(R) ! THH(R) ! (R)$$
(1.1)

when R is a commutative ring spectrum. The rst two arrows are de ned for any (symmetric) ring spectrum, whereas the de nition of the last map depends on R being commutative. By de nition, THH(R) is the in nite loop space associated to the realization of the cyclic spectrum $[k] \not P R^{\wedge (k+1)}$ with Hochschild type structure maps. We shall use Bökstedt's explicit de nition of the smash products $R^{\wedge (k+1)}$. If R is commutative, the degree-wise multiplication $R^{\wedge (k+1)}$! R de nes a map to the constant cyclic spectrum. This gives rise to the in nite loop map r in the de nition of R.

In order to state our main result, we need the fact that $GL_1(R)$ has the structure of an in nite loop space when R is commutative, ie, that there exists a spectrum $gl_1(R)$ such that ${}^{-1}(gl_1(R)) \ ' \ GL_1(R)$. (We follow the convention to use small letters for the spectrum associated to an in nite loop space written in capital letters.) It will be convenient for our purpose to give an explicit construction of $gl_1(R)$ using Segal's notion of -spaces. Let $2 {}^{s}_1(S^0)$ denote the stable Hopf map.

Theorem 1.2 The composite map $_R$ admits a factorization

 $BGL_1(R) ! GL_1(R) ! ^{1}(R);$

in which the second map is the natural inclusion and the second map is multiplication by in the sense of the following commutative diagram in the homotopy

category of spaces,

$$\begin{array}{cccc} BGL_{1}(R) & ---! & GL_{1}(R) \\ \overbrace{}^{\gamma} & \overbrace{}^{\gamma} \\ \downarrow & & \downarrow \\ \end{array}$$

In the case where R equals the sphere spectrum this result is due to Bökstedt and Waldhausen [8] (with a completely di erent proof).

It is clear from the de nition that there is an isomorphism of abelian groups ${}_{i}gl_{1}(R) = {}_{i}R$ for i = 1, but since the spectrum structures are di erent this is not an isomorphism of ${}^{s}(S^{0})$ -modules. However, using that is realized as an unstable map : $S^{3} ! S^{2}$, it is not di cult to check that the actions of are compatible in degrees i = 2. The following is then an immediate corollary of Theorem 1.2.

Corollary 1.3 For *i* 3, the composition

$$_{i-1}R = _{i}BGL_{1}(R) ! _{i}K(R) ! _{i}THH(R) ! _{i}R$$

is multiplication by $2 {}^{s}_{1}(S^{0})$.

It thus follows that classes in $_{i-1}R$ not annihilated by give rise to non-trivial elements in $_{i}K(R)$.

Example 1.4 Let R = ko, the real connective K-theory spectrum. In this case $GL_1(ko) \ ' \ f \ 1g \ BO$, where indicates that the H-space structure is the one corresponding to tensor products of vector bundles. Using the co bration sequence $ko \ ko \ ko \ ku$, [18, V.5.15], we see that

$$\mathbb{Z} = {}_{8k}(ko) ! {}_{8k+1}(ko) = \mathbb{Z} = 2$$

is surjective and that

$$\mathbb{Z}=2=8_{k+1}(k0)$$
 ! $8_{k+2}(k0)=\mathbb{Z}=2$

is an isomorphism. We conclude that for k = 1,

 $_{8k+1}BBO = \mathbb{Z}$ maps non-trivially to $_{8k+1}K(ko)$;

 $_{8k+2}BBO = \mathbb{Z}=2$ injects as a direct summand in $_{8k+2}K(ko)$.

This example is interesting in view of the attempts [1], [2], to relate algebraic Ktheory to elliptic cohomology and the chromatic ltration of homotopy theory. Another major source for the interest in algebraic K-theory in the non-linear setting is the relation to high dimensional manifold theory via Waldhausen's work on stable concordances [20].

Example 1.5 Let $R = {}^{1}(G_{+})$ be the suspension spectrum of a commutative (or E_{1}) group-like monoid G. By de nition, the algebraic K-theory of this spectrum is Waldhausen's A(BG). In this case, ${}_{i}BGL_{1}(R) = {}^{s}_{i-1}(G_{+})$, and thus classes in the stable homotopy that are not annihilated by map non-trivially to ${}_{i}A(BG)$ in degrees i = 3.

Remark 1.6 Given a discrete ring *R*, the algebraic K-theory of the associated Eilenberg-MacLane spectrum *HR* reduces to Quillen's K(R). Starting with a ring spectrum *R* and $R = {}_0R$, the linearization map *R* ! *HR* gives rise to a bration sequence

F ! K(R) ! K(R);

where by denition F is the homotopy bre. Let $SL_1(R)$ be the unit component of $GL_1(R)$. Using that $BSL_1(R) =$ we get a map $BSL_1(R) ! F$ which is important in the understanding of how algebraic K-theory behaves under linearization.

The proof of Theorem 1.2 breaks up into two parts. The rst part is to give a description of $_R$ in non-K-theoretical terms as the composition

$$BGL_1(R)$$
 ! $L(BGL_1(R))$ $B^{cy}GL_1(R)$! $GL_1(R)$ ¹ (R)

Here $L(BGL_1(R))$ denotes the free loop space of $BGL_1(R)$ and $B^{cy}GL_1(R)$ is Waldhausen's cyclic bar construction, see Section 3. The rst map is the inclusion of the constant loops and the map r: $B^{cy}GL_1(R)$! $GL_1(R)$ is given by iterated multiplication in $GL_1(R)$. The fact that $GL_1(R)$ is an in nite loop space ensures that it is su ciently homotopy commutative for the latter map to be well-de ned.

The second part of the proof is then to show that the composite map $BGL_1(R)$ *!* $GL_1(R)$ is multiplication by . This follows from a general analysis of how the free loop space of an in nite loop space relates to the cyclic bar construction. Let us say that a sequence of maps of based spaces $F \, ! \, X \, ! \, Y$ is a homotopy bration sequence if (i) the composition is constant and (ii) the canonical map from F to the homotopy ber of the second map is a weak homotopy equivalence. (This de nition is most useful if Y is connected.) Given a

well-pointed group-like topological monoid G, there is a commutative diagram of homotopy bration sequences

in which the lower sequence is split by the inclusion of the constant loops BG ! L(BG). If furthermore G admits the structure of an in nite loop space, then the upper sequence has a natural splitting $B^{cy}G ! G$ given by the iterated product in G. The failure of these splittings to be compatible is measured by the fact that the composition

is multiplication by in the sense described above for $GL_1(R)$.

The paper is as a whole fairly self-contained, and in particular we present in Section 4 a new explicit construction of the trace map tr: K(R) ! THH(R). This version of the trace map is used here to identify the action on $BGL_1(R)$, but there are many other applications of this combinatorial construction. In Section 2 we recall the de nition of symmetric ring spectra and their units and in Section 3 we recall Waldhausen's de nition of algebraic K-theory in this framework. The Sections 2-4 can be read as a self-contained account of the topological trace map.

In Section 5 we explain the in nite loop structure of $GL_1(R)$ used in the formulation of Theorem 1.2, and in Section 6 we construct the splitting r: THH(R) !

 7 (*R*) and complete the rst part of the proof. Finally, in Section 7 we consider the relationship between the free loop space and the cyclic bar construction of an in nite loop space and nish the second part of the proof.

1.1 Notation and conventions

Let T be the category of based spaces. In this paper this can be understood as either the category of compactly generated Hausdor (or weak Hausdor) topological spaces or the category of based simplicial sets. However, we will usually use the topological terminology and talk about topological monoids etc. In both cases equivalences mean weak homotopy equivalences. In the topological case we will sometimes have to assume that base points are nondegenerate in the usual sense of being neighborhood deformation retracts. We let S^n denote the *n*-fold smash product of the circle $S^1 = I = @I$. By a spectrum *E* we understand a sequence $fE_n: n \quad 0g$ of based spaces together with based maps $: S^1 \land E_n ! E_{n+1}$. Again this may be interpreted either in the topological or simplicial category. A map of spectra f: E ! F is a sequence of based maps $f_n: E_n ! F_n$ that commute with the structure maps. We say that *f* is an equivalence if it induces an isomorphism on spectrum homotopy groups, the latter being de ned by ${}_nE = \operatorname{colim}_k {}_{n+k}E_k$. All spectra we consider will be connective, ie, ${}_nE = 0$ for n < 0. We shall also assume that the spectra we consider are *convergent* in the sense that there exists an unbounded, non-decreasing sequence of natural numbers $f_n: n \quad 0g$ such that $S^1 \land E_n ! E_{n+1}$ is as least n + n-connected for all n. This is not a serious restriction as any connective spectrum is equivalent to a convergent one.

2 Units of ring spectra

In this section we recall Waldhausen's de nition of the space of units associated to a ring spectrum. We shall work in the framework of symmetric spectra and begin by recalling the relevant de nitions from [12] and, for the version with topological spaces instead of simplicial sets, [16].

2.1 Symmetric spectra

A symmetric spectrum is a spectrum in which each of the spaces E_n is equipped with a base point preserving left n-action, such that the iterated structure maps

m
: $S^{m} \wedge E_{n} ! E_{m+n}$

are m n-equivariant. A symmetric ring spectrum is a symmetric spectrum equipped with n-equivariant maps 1_n : $S^n ! E_n$ for n = 0, and $m = n^-$ equivariant maps m_n : $E_m \land E_n ! E_{m+n}$ for $m_n = 0$. In order to formulate the axioms, let n be the composite

$${}^{n}: E_{m} \wedge S^{n} \stackrel{\mathrm{tw}}{\to} S^{n} \wedge E_{m} \stackrel{n}{\to} E_{n+m} \stackrel{n}{\to} E_{m+n};$$

where tw twists the two factors, and n;m is the (n;m)-shu e $i \not \nabla i + m$ for i = n, $i \not \nabla i - n$ for i > n. Notice that n is m n-equivariant. Also, let $0: S^0 \wedge E_n ! E_n$ and $0: E_n \wedge S^0 ! E_n$ be the canonical identi cations. These maps are required to satisfy the following relations for all l;m;n=0:

(a)
$$1_{m+n} = {}^{m} (S^{m} \wedge 1_{n}),$$

- **(b)** $^{m} = _{m;n} (1_{m} \wedge E_{n}); \quad ^{n} = _{m;n} (E_{m} \wedge 1_{n}),$
- (c) $l_{l+m;n}$ $(l_{l;m} \wedge E_n) = l_{l;m+n}$ $(E_l \wedge m_{l;n}).$

Here condition (a) states that the maps 1_n assemble to give a map of spectra 1: $S \ ! E$, where S denotes the sphere spectrum. Notice that (b) and (c) imply that

$$I_{i,m+n} \quad (E_{I} \wedge m) = I_{i+m,n} \quad (m \wedge E_{n})$$

as maps $E_I \wedge S^m \wedge E_n ! E_{I+m+n}$ and that

$$(S^{I} \wedge m; n) = I + m; n \quad (I^{I} \wedge E_{n}):$$

These are exactly the conditions for the maps m_{in} to produce a map of spectra : $E \wedge E ! E$, where the domain is the internal smash product in the category of symmetric spectra. Condition (b) then says that 1 is a two-sided unit, and (c) is the condition that the multiplication is associative. (These comments on the internal smash product are only to motivate the de nitions; we shall not make explicit use of the internal smash product in this paper.) We say that R is commutative if the diagrams

$$R_{m} \stackrel{\wedge}{\underset{j \neq w}{}} R_{n} \stackrel{-\underline{m}:\underline{\eta}}{\underset{j \neq w}{}} R_{\underline{m}+n}$$

$$R_{n} \stackrel{\wedge}{\underset{m}{}} R_{m} \stackrel{-\underline{m}:\underline{\eta}}{\underset{j \neq w}{}} R_{n+m}$$

are commutative.

2.2 / -spaces and / -monoids

In order to de ne the units of a symmetric ring spectrum we need a combinatorial framework to keep track of the suspension coordinates. Let *I* be the category whose objects are the nite sets $\mathbf{n} = f_{1} : :::; ng$ and whose morphisms are the injective (not necessarily order preserving) maps. The empty set $\mathbf{0}$ is an initial object. The concatenation $\mathbf{m} t \mathbf{n}$ de ned by letting \mathbf{m} correspond to the rst *m* elements and \mathbf{n} to the last *n* elements of $f_{1} : :::; m + ng$ gives *I* the structure of a symmetric monoidal category. The symmetric structure is given by the shu es m;n: $\mathbf{m} t \mathbf{n} ! \mathbf{n} t \mathbf{m}$.

We de ne an *I*-space to be a functor X: *I*! *T*. Given an *I*-space X, we write X_{hI} = hocolim_{*I*} X. The homotopy type of X_{hI} can be analyzed using the following lemma due to Bökstedt. For published versions see [15, 2.3.7] and [9, 2.5.1]. Let F_nI be the full subcategory of *I* containing the objects of cardinality at least *n*.

Lemma 2.1 (Bökstedt) Let X be an *I*-space and suppose that each morphism $\mathbf{n}_1 \mid \mathbf{n}_2$ in $F_n \mid induces a_n$ -connected map $X(n_1) \mid X(n_2)$. Then, given any object \mathbf{m} in $F_n \mid i$, the natural map $X(m) \mid X_{hl}$ given by the inclusion in the 0-skeleton is at least (n - 1)-connected.

Let us say that an *I*-space X is *convergent* if there exists an unbounded, nondecreasing sequence of natural numbers f_n : $n ext{ 0}g$ such that any morphism $\mathbf{n}_1 ! \mathbf{n}_2$ in $F_n I$ induces a n-connected map $X(n_1) ! X(n_2)$. It follows from Bökstedt's lemma that in this case X_{hI} is equivalent to the usual telescope of the sequence of spaces X(n) obtained by restricting to the natural subset inclusions in *I*. In particular, X_{hI} is the usual directed colimit of the groups X(n) if X is convergent.

We say that an I-space X is an I-monoid if it comes equipped with an associative and unital natural transformation

$$m:n: X(m) = X(n) ! X(m+n);$$

where both sides are considered functors on I^2 . The unital condition means that the basepoint in X(0) acts as a unit and associativity means that the identity

$$I_{m+n} (X_{l} m_{n}) = I_{m+n} (I_{m} X_{n})$$

holds for all I; m; n = 0. By de nition an I-monoid X is commutative if the diagrams

$$\begin{array}{c} X(m) \\ \vdots \\ y tw \end{array} \xrightarrow{m:n} X(m+n) \\ \vdots \\ y tw \end{array}$$

are commutative. If X is an I-monoid, then X_{hI} inherits the structure of a topological monoid. The product is given by the composition

$$X_{hI} \quad X_{hI} = \operatorname{hocolim}_{I} X(m) \quad X(n) \ ! \ \operatorname{hocolim}_{I} X(m+n) \ ! \ X_{hI};$$

in which the last map is induced by the monoidal structure of I. We say that X is group-like if this is the case for X_{hI} , ie, if the monoid of components ${}_{0}X_{hI}$ is a group. We will show in Section 5 that if X is commutative and group-like, then X_{hI} has the structure of an in nite loop space.

Remark 2.2 For *I*-spaces X that are not convergent, the homotopy type of X_{hI} may well di er from that of the usual telescope. Consider for example the *I*-monoid **n** \mathcal{V} B_{n} . In this case the associated homotopy colimit is equivalent

to the base point component of $Q(S^0)$. To see this one uses that the natural map B_{-1} ! hocolim₁ B_{-n} induces an isomorphism on integral homology. By the universal property of Quillen's plus-construction and the fact that the target is a connected H-space, it follows that the latter is equivalent to B_{-1}^+ . The conclusion then follows from the Barratt-Priddy-Quillen-Segal Theorem. As a second example, let R be a discrete ring and consider the *I*-monoid de ned by the classifying spaces $BGL_n(R)$. By an argument similar to the above, the associated homotopy colimit is equivalent to the base point component of the algebraic K-theory space K(R). In these examples (and many more), evaluating the homotopy colimit over *I* thus has the same e ect as Quillen's plus-construction.

2.3 Units of ring spectra

Given a symmetric ring spectrum R, the sequence of spaces ${}^{n}(R_{n})$ de nes an I-space as follows. A morphism : **m** ! **n** in I induces a map ${}^{m}(R_{m})$! ${}^{n}(R_{n})$ by taking $f 2 {}^{m}(R_{m})$ to the composition

$$S^{n} - \vec{I}^{n} S^{n} = S^{I} \wedge S^{m} - \vec{I}^{I} S^{I} \wedge R_{m} - \vec{I} R_{n} - R_{n}$$
(2.3)

Here : $\mathbf{n} = \mathbf{l} t \mathbf{m} ! \mathbf{n}$ is the unique permutation that is order preserving on the rst l = n - m elements and acts as on the last *m* elements. The action on S^n is the usual left action. The multiplication in *R* gives a multiplicative structure

$$_{m;n}: \ \ {}^{m}(R_{m}) \ \ {}^{n}(R_{n}) \ ! \ \ {}^{m+n}(R_{m+n}); \\ _{m;n}(f;g): \ S^{m} \land S^{n} \ {}^{f \land g} R_{m} \land R_{n} \ {}^{m+n}(R_{m+n});$$

which is commutative if R is. We let ${}^{n}(R_{n})$ be the union of the components in ${}^{n}(R_{n})$ that have stable multiplicative homotopy inverses in the following sense: For each f in ${}^{n}(R_{n})$ there exists an element $g \ 2 {}^{m}(R_{m})$ such that ${}_{n:m}(f;g)$ and ${}_{m:n}(g;f)$ are homotopic to the unit 1_{m+n} in ${}^{m+n}(R_{m+n})$. We consider ${}^{n}(R_{n})$ as a based space with base point 1_{n} and restricting the above structure maps gives an I-monoid ${}^{n}(R_{n})$. We de ne

$$GL_1(R) = \text{hocolim} \ ^n(R_n)$$

with the monoid structure explained above. If *R* is convergent so is the *I*-space ${}^{n}(R_{n})$, and by Lemma 2.1, ${}_{0}(GL_{1}(R)) = GL_{1}({}_{0}(R))$. If furthermore *R* is commutative, the general construction in section 5 will produce a spectrum $gI_{1}(R)$ such that ${}^{1}(gI_{1}(R)) ' GL_{1}(R)$.

3 K-theory and cyclic K-theory of ring spectra

In this section we recall the de nition of the algebraic K-theory K(R) and the cyclic algebraic K-theory $K^{cy}(R)$ of a symmetric ring spectrum R. We also recall the inclusion of the units $BGL_1(R)$! K(R). This material is due mainly to Waldhausen. Let $M_n(R)$ be the symmetric ring spectrum whose *m*th space is Map $(\mathbf{n}_+, \mathbf{n}_+ \land R_m)$. The multiplication resembles multiplication of n - n matrices over an ordinary ring. (In this case the \matrices" in question have at most one non-base point entry in each column.) We let $GL_n(R) = GL_1(M_n(R))$ with the monoid structure coming from the multiplication in $M_n(R)$. Using the natural maps

we have a notion of block sum of matrices and corresponding monoid homomorphisms

$$GL_m(R)$$
 $GL_n(R)$! $GL_{m+n}(R)$:

These homomorphisms are associative in the obvious sense and thus the induced maps of classifying spaces give $_{n=0} BGL_n(R)$ the structure of an associative topological monoid. By de nition K(R) is the group completion

$$K(R) = B \overset{id}{B} BGL_n(R) :$$

Notice that this is the version of algebraic K-theory with $_0 K(R) = \mathbb{Z}$.

The classifying space of the units $BGL_1(R)$ embeds in the 1-simplices of B ($_{n=0}BGL_n(R)$) and since there is just a single 0-simplex there is an induced map

$$S^{1} \wedge BGL_{1}(R)_{+} ! B \overset{a}{B} BGL_{n}(R)_{n 0}$$

whose adjoint is the requested map $BGL_1(R)$! K(R). The image is contained in the 1-component of K(R).

There is a variant of all this using the cyclic bar construction $B^{cy}GL_n(R)$. Recall that for a topological monoid G, $B^{cy}G$ is the realization of the cyclic space $[k] \not P \quad G^{k+1}$ with simplicial operators

$$d_{i}(g_{0}; \dots; g_{k}) = \begin{cases} (g_{0}; \dots; g_{i}g_{i+1}; \dots; g_{k}); & \text{for } 0 & i < k \\ (g_{k}g_{0}; \dots; g_{k-1}); & \text{for } i = k \end{cases}$$

$$s_{i}(g_{0}; \dots; g_{k}) = (g_{0}; \dots; g_{i}; 1; \dots; g_{k}); & \text{for } 0 & i \quad k;$$

and cyclic operator $t_k(g_0; \ldots; g_k) = (g_k; g_0; \ldots; g_{k-1})$. We refer the reader to [13] for background material on cyclic spaces. The degree-wise projections $(g_0; \ldots; g_k) \not \ (g_1; \ldots; g_k)$ de ne a simplicial map $p: B^{cy}G ! B G$, and if Gis group-like and has a non-degenerate unit there results a homotopy bration sequence

$$G ! B^{cy}G ! BG$$

Since $B^{cy}G$ is a cyclic space its realization has a canonical action of the circle group \mathbb{T} . Consider the composite map \mathbb{T} $B^{cy}G$! $B^{cy}G$! BG, where the rst map is given by the \mathbb{T} -action. Letting L(-) denote the free loop space, the adjoint is a map $B^{cy}G$! L(BG). It is immediate from the de nition that this is a \mathbb{T} -equivariant map when the action on L(BG) is by multiplication in \mathbb{T} . The following proposition is well-known and follows easily from the de nition of the \mathbb{T} -action. We shall prove a related result in Proposition 7.1 with a proof that can easily be adapted to the present situation.

Proposition 3.1 There is a commutative diagram

in which the lower sequence is the usual bration sequence associated to the evaluation at the unit element of \mathbb{T} . If *G* is group-like and has a non-degenerate unit, then the upper sequence is a homotopy bration sequence and the vertical maps are equivalences.

Notice that the lower sequence in (3.1) is split by the inclusion of BG in L(BG) as the constant loops. By de nition the cyclic K-theory of a symmetric ring spectrum R is given by

$$K^{cy}(R) = B \overset{a}{\underset{n \ 0}{}} B^{cy}GL_n(R) :$$

The projections $p: B^{cy}GL_n(R) ! BGL(R)$ induce a map $p: K^{cy}(R) ! K(R)$ which has a section in the homotopy category. The quickest way to see this is to consider the diagram of monoid homomorphisms

4 Topological Hochschild homology and the trace map

In this section we present an explicit construction of the topological trace map tr: K(R) ! THH(R), where the target is the topological Hochschild homology. In order to motivate the construction we rst recall the linear trace map for an ordinary discrete ring tr: K(R) ! HH(R) with target the Hochschild homology of R. The latter is the realization of a cyclic abelian group HH (R): [k] $\not P$ R ^{k+1} with cyclic structure maps similar to $B^{cy}G$. The multi-trace tr: HH ($M_n(R)$) ! HH (R) is the cyclic map given in degree kby

Composing with the obvious inclusions $B^{cy}GL_n(R)$! HH ($M_n(R)$) we get a cyclic map

This is a monoid homomorphism with respect to block-sums of matrices on the domain and the abelian group structure on the target. After realization and group completion we get maps

The linear trace map tr: K(R) ! HH(R) is the homotopy class obtained by composing with the homotopy section K(R) ! $K^{cy}(R)$.

4.1 Topological Hochschild homology

Topological Hochschild homology is obtained by replacing the tensor products in HH (R) by smash products of spectra. We shall follow Bökstedt [6] in making this precise. Given a sequence of symmetric spectra E^1 ;...; E^r , we consider the smash product as a multi-indexed spectrum in the natural way,

$$(E^{1} \wedge \cdots \wedge E^{r})_{n_{1},\dots,n_{r}} = E^{1}_{n_{1}} \wedge \cdots \wedge E^{r}_{n_{r}}$$

In general an *r*-fold multi-indexed symmetric spectrum $E = fE_{n_1,...,n_r}g$ has an associated in nite loop space

$$^{1}(E) = \operatorname{hocolim}_{lr} \, {}^{n_{1}+ + n_{r}}(E_{n_{1}, \dots, n_{r}}):$$

The functoriality underlying this de nition is analogous to that in (2.3). We shall always use the symbol $^{1}(E)$ in this precise way. Notice that the monoidal structure of I^{r} makes 1 a functor from multi-indexed spectra to topological monoids. The topological Hochschild homology of a ring spectrum R is the topological realization of the cyclic spectrum TH (R), de ned in spectrum degree n by

The spectrum structure maps are de ned in the obvious way involving only the S^n -factor. This construction represents Bökstedt's solution to the problem of how to turn the multi-indexed spectrum $R^{\wedge (k+1)}$ into an equivalent singlyindexed spectrum. The cyclic structure maps are analogous to those in $B^{cy}(G)$ and HH (R). Thus for example d_0 : TH₁(R) ! TH₀(R) is the composition

where the rst map uses the multiplication in R and the second map is induced by the monoidal structure t: I I! I. It follows from the version of Bökstedt's approximation Lemma 2.1 with I^{k+1} instead of I that TH(R) is an -spectrum, and we let THH(R) be the 0th space.

In order to de ne the spectrum level multi-trace, we need to model the additive structure of a spectrum in a very precise way. We next explain how this can be done.

4.2 The cyclic Barratt-Eccles construction

Let *E* $_{n}$ be the cyclic set $[k] \not \!\!\! / \quad \stackrel{k+1}{n}$ with simplicial operators

and cyclic operator $t_k(_{0}; \ldots; _{k}) = (_{k};_{0}; \ldots; _{k-1})$. We let \mathbb{E}^{1} be the cyclic Barratt-Eccles operad with *n*th space E_{-n} , see [3], [17, 6.5]. This is an E_{1} operad in the sense that the realization E_{-n} of the *n*th space is __n-free and contractible. We use the notation \mathbb{E}^{1} for the associated functor from based spaces to simplicial based spaces,

where the equivalence relation is defined as follows. In other words, $\mathbb{E}^{1}(X)$ is the tensor product of the functors $\mathbf{n} \ \mathcal{V} \ E_{n}$ and $\mathbf{n} \ \mathcal{V} \ X^{n}$ over I, ie, the coend of the $I^{\text{op}} \ I$ -diagram $E_{m} \ X^{n}$, cf. [14, IX.6]. We let $\mathbb{E}^{1}(X)$ be the realization. (Barratt and Eccles use the notation $^{+}(X)$, but we want to avoid this since we also use -spaces in the sense of Segal.) We write the elements of $\mathbb{E}^{1}(X)$ as $[\ \mathbf{x}]$ where $2 \ E_{k}$ and $\mathbb{E}^{1}(X)$ as $[\ \mathbf{x}]$ where $(X) \ \mathbf{x}$ and $(X) \ \mathbf{x}$ and (X

of Segal.) We write the elements of $\mathbb{E}^{\uparrow}(X)$ as $[\neg \mathbf{x}]$ where $2 E_k$ and $\mathbf{x} \ 2 \ X^k$. Block sums of permutations give $\mathbb{E}^{\uparrow}(X)$ the structure of a simplicial topological monoid,

The homotopy theoretical signicance of the functor $\mathbb{E}^{1}(X)$ is that it provides a combinatorial model of $\overset{1}{} \overset{1}{} (X)$ for non-degenerately based connected X. In more detail, it is proved in [3] that in the diagram

$$\mathbb{E}^{1}(X) \ ! \ \operatorname{colim} \ ^{n}\mathbb{E}^{1}(S^{n} \wedge X) \quad \operatorname{colim} \ ^{n}(S^{n} \wedge X);$$

the left hand arrow is an equivalence for connected X and the right hand arrow is an equivalence in general.

We extend \mathbb{E}^{1} to a functor on (symmetric) spectra by applying it in each spectrum dimension, ie, $\mathbb{E}^{1}(E)_{n} = \mathbb{E}^{1}(E_{n})$ with structure maps

$$S^{1} \wedge \mathbb{E}^{1} (E_{n}) ! \mathbb{E}^{1} (S^{1} \wedge E_{n}) ! \mathbb{E}^{1} (E_{n+1}):$$

Since we assume spectra to be connective and convergent, it easily follows that the natural map $E \mathrel{!} \mathbb{E}^{1}(E)$ is an equivalence. Similarly, given a simplicial spectrum, we may apply \mathbb{E}^{1} degree-wise to get a bisimplicial spectrum and then restrict to the simplicial diagonal. This is in e ect what we shall do when de ning the spectrum level multi-trace.

4.3 The spectrum level multi-trace

The multi-trace for a symmetric ring spectrum R is a natural map of multiindexed spectra

Let us rst explain how to de ne this when R is a spectrum of based simplicial sets. In this case tr is based on a natural transformation

Since by denition the matrices have at most one non-base point entry in each column, the projections $(s_0; \ldots; s_k) \not \!\!\!/ s_i$ give rise to injective maps $p_i: D !$ **n**. Suppose that D has cardinality m and order the elements by choosing a bijection : **m** ! D. The composition $p_i : \mathbf{m} ! \mathbf{n}$ is injective for each i and admits a unique factorization $p_i = i_i$, where i_i is injective and order preserving and $i_i 2_m$. Consider the natural map

The second observation is that because of the base point relations in the target this construction is natural with respect to based maps in X_0 ; ..., X_k .

Example 4.4 As an example to illustrate the construction we calculate

The spectrum level multi-trace (4.2) is de ned by degree-wise extending the above natural transformation to a natural transformation between functors of simplicial sets. We then extend this to a natural transformation of multi-indexed spectra by applying it in each multi-degree. This gives the required maps

$$M_n(R_{n_0}) \wedge \dots \wedge M_n(R_{n_k}) ! \mathbb{E}_k^{\uparrow} (R_{n_0} \wedge \dots \wedge R_{n_k})$$

In the case where R is a spectrum of topological spaces we observe that the expression in (4.3) also makes sense if X_0 ; ...; X_k are (non-degenerately) based topological spaces, and we de ne tr by the same formula.

4.4 The topological trace map

We de ne a combinatorially enriched version $TH^+(R)$ of topological Hochschild homology by applying Bökstedt's construction to the multi-indexed spectrum on the right hand side of (4.2), ie,

$$\mathrm{TH}^+(R;n): [k] \, \mathcal{I}^{-1}(\mathbb{E}^{1}_{k}(\underline{R}^{\wedge}_{\{\underline{Z}} \wedge \underline{R}^{\wedge}_{k+1})):$$

This is in a natural way the cyclic diagonal of a bicyclic spectrum. The + decoration indicates that $\text{TH}^+(R;n)$ is a homotopy commutative cyclic monoid. Using the natural inclusion $X \not P \equiv {}^1(X)$ we get a degree-wise equivalence TH (*R*) ! TH⁺(*R*) and thus an equivalence of realizations TH(*R*) ! TH⁺(*R*). The spectrum level multi-trace has formal properties similar to the linear multi-trace and in particular there results a cyclic map

(One can show that the realization can be extended to give an equivalence of \mathbb{T} -equivariant spectra, but we shall not use this here.) The de nition of the topological trace map is now completely analogous to the linear case. There is an obvious embedding of cyclic spaces $B^{cy}GL_n(R)$! THH ($M_n(R)$) induced by the natural transformation

Remark 4.6 It is not di cult to extend this de nition of the trace map to a map of spectra or to re ne it to a version of the cyclotomic trace trc: K(R) ! TC(R), cf. [7]. However, this is not the purpose of the present paper. A construction of the trace map from a more categorical point of view has been given by Dundas and McCarthy [11] and Dundas [10].

Letting n = 1 in (4.5) gives a map $B^{cy}GL_1(R)$! THH(R). The following proposition is immediate from the de nitions

Proposition 4.7 There is a strictly commutative diagram of spaces

5 -spaces and units of commutative ring spectra

In this section we show that if R is a commutative (and convergent) ring spectrum, then $GL_1(R)$ is the 0th space of an -spectrum. The same is true for the group-like monoid X_{hI} associated to a commutative and group-like I-monoid X, and we formulate the construction in this generality.

5.1 -spaces

We rst recall Segal's notion of -spaces and the Anderson-Segal method for constructing the associated homology theory. The paper by Bous eld and Friedlander [4] is the basic reference for this material. Let ^o denote the category of nite pointed sets and pointed maps. A -space is a functor A: ^o ! T such that A() =. We say that a -space is *special* if given pointed sets *S* and *T* the natural map $A(S_T)$! A(S) = A(T) is an equivalence. This

implies in particular that $A(S^0)$ has the structure of a homotopy associative and commutative H-space with multiplication

$$A(S^0) \quad A(S^0) \stackrel{\prime}{} A(S^0 _ S^0) \stackrel{!}{} A(S^0):$$

We say that A is *very special* if $A(S^0)$ is group-like, ie, if the monoid of components is a group. A -space A extends to a functor on the category of pointed simplicial sets in a two stage procedure. First A is extended to the category of all pointed sets by forcing it to commute with colimits. Given a simplicial set X we then apply A degree-wise to get a simplicial space $[k] \not P A(X_k)$ with realization A(X). The main result is that if A is very special then the resulting functor is a homology theory: Applying A to a co bration sequence of pointed simplicial sets X ! Y ! Y = X gives a homotopy bration sequence

$$A(X) ! A(Y) ! A(Y=X)$$

in the sense that the inclusion of A(X) in the homotopy ber of the second map is an equivalence. In particular, a very special -space gives rise to a symmetric

-spectrum $fA(S^n)$: n = 0g, in which the structure maps are the realizations of the obvious (multi)-simplicial maps $S^1 \wedge A(S^n) ! = A(S^{n+1})$.

5.2 -spaces associated to commutative / -monoids

In order to motivate the construction we recall the denition of the -space associated to a commutative topological monoid *G*. Given a nite based set *S*, let *S* be the subset obtained by excluding the base point. Then $G(S) = G^S$, and a based map : S ! T induces a map G(S) ! G(T) by multiplying the elements in *G* indexed by ^{-1}ftg for each t 2 T.

Implementing this idea for a commutative *I*-monoid requires some preparation. Given *S* as above, let P(S) be the category of subsets and inclusions in *S*. A based map : *S* ! *T* induces a functor : P(T) ! P(S) by letting $(U) = {}^{-1}(U)$ for U *T*. We de ne a category D(S) of *S*-indexed sum

(U) = -I(U) for U = T. We de he a category D(S) of S-indexed sum diagrams in I as follows. An object is a functor : P(S) ! I that takes disjoint unions to coproducts of nite sets, ie, if $U \setminus V = f$, then the diagram $U ! U_{IV} = V$ represents U_{IV} as a coproduct of nite sets. (The category I itself does of course not have coproducts.) Notice in particular that f = 0. A morphisms in D(S) is a natural transformations of functors (not necessarily an isomorphism). This construction is clearly functorial in O: A based map : S ! T induces a functor : D(S) ! D(T) by letting = . Notice that an object in D(S) is determined by

its values $_{s}$ for s 2 S;

a choice of injective map s! = U whenever $s \ge U$ such that the induced map $t_{s\ge U} s! = U$ (with any ordering of the summands) is a bijection.

Restricting to the one-point subsets of *S* gives a functor $_{S}$: $D(S) ! I^{S}$, where the latter denotes the product category indexed by *S* (we let I^{r} denote the one-point category). This is an equivalence of categories, and specifying an ordering of *S* gives a canonical choice of an inverse functor $I^{S} ! D(S)$, using the monoidal structure of *I*. Notice however, that I^{S} is not functorial in o as is the case for D(S).

Lemma 5.1 Given a functor $Y : I^{S} ! T$, the natural map $\begin{array}{ccc} & & & \\ & & & \\ & & & \\ D(S) & & & \\ & & & \\ & & & \\ & & & \\ & & & \\ & & & \\ &$

induced by s is an equivalence.

Proof By the conality criterion in [5, XI.9.2] (or rather its dual version) it su ces to check that for any object **a** $2 I^S$, the category (**a** $\#_S$) of objects under **a** is contractible. But this is clear since this category has an initial object.

Let now X be a commutative *I*-monoid and consider the I^{S} -diagram X^{S} de ned by

For S = : this should be interpreted as the one-point space. We use the notation X(S) for the D(S)-diagram obtained by composing with S. With this de nition X(S) is functorial in S is the sense that a based map S : S ! T gives rise to a natural transformation of D(S) diagrams

;

In order to see this x an object in D(S) and choose an ordering of the subsets $U_t = {}^{-1}(t)$ for each $t \ 2 \ 7$. The map in question is then a product over T of maps of the form

where the rst arrow comes from the multiplication in X and the second arrow is induced by the bijection $t_{s2U_t \ s} ! U_t$ determined by the sum diagram. The main point is that since X is commutative the composite map does not depend on the ordering of U_t used to de ne it.

By de nition the -space associated to X is given by

$$X_{hI}(S) = \operatorname*{hocolim}_{D(S)} X(S)$$

Given a based map : S ! T, the induced map : $X_{hI}(S) ! X_{hI}(T)$ is the composition

$$\operatorname{hocolim}_{D(S)} X(S) \ ! \ \operatorname{hocolim}_{D(T)} X(T) \qquad ! \ \operatorname{hocolim}_{D(T)} X(T);$$

where the rst map is induced by the above natural transformation and the second map is the map of homotopy colimits determined by the functor .

It follows immediately from the de nition that $X_{hl}(S^0) = X_{hl}$. In order to compare $X_{hl}(S^1)$ to the usual bar construction of X_{hl} we specify an ordering of the *k*-simplices in S^1 by letting

Then u_0 is the base point and $S_k^1 = f u_1 : ::: u_k g$.

Proposition 5.3 The -space associated to a commutative *I*-monoid X is always special and is very special if and only if the underlying monoid X_{hI} is group-like. In general there is a natural equivalence BX_{hI} ! $X_{hI}(S^1)$.

Proof Using Lemma 5.1 we get an equivalence

$$X_{hI}(S) = \underset{D(S)}{\operatorname{hocolim}} X(S) ! \operatorname{hocolim}_{I^{S}} X^{S} = \bigvee_{S^{2S}}^{Y} X_{hI};$$

which is the condition for X_{hl} to be special. The statement about being very special follows from the de nition. In order to de ne the equivalence we use the ordering of the simplices of S^1 given by (5.2). As noted earlier this ordering determines an equivalence

using the monoidal structure of I. Identifying the left hand side with the k-simplices of $B X_{hI}$ we get a simplicial map $B X_{hI} ! X_{hI} (S^1)$. Since this is an equivalence in each simplicial degree its realization is also an equivalence as required.

Remark 5.4 This construction of -spaces based on the category D(S) di ers from that of Segal [19, x^2] in that we allow all natural transformations, not only the natural isomorphisms. Consequently, our de nition of the -space associated to a commutative l -monoid takes into account all the maps X(m) ! X(n) induced by morphisms in l. As an example, consider the commutative l -monoid given by the classifying spaces BO(n) of the orthogonal groups. In this case Segal's construction produces a special -space with underlying space BO(n), whereas our construction produces a very special -space with underlying space hocolim_l <math>BO(n) ' BO. The last equivalence follows from Bökstedt's Lemma 2.1. Thus the two constructions respectively produce models of the (-1)-connected and 0-connected topological K-theory spectrum.</sub>

De nition 5.5 Given a commutative (and convergent) symmetric ring spectrum R, let $GL_1(R)$ be the -space associated to the I-monoid ${}^n(R_n)$ considered in Section 2.3, and let $gI_1(R)$ be the associated spectrum.

It will always be clear from the context whether $GL_1(R)$ denotes a -space as above or the underlying group-like monoid as in Section 2.

6 Commutative ring spectra and splittings

Let *R* be a commutative symmetric ring spectrum. In this section we show that the natural inclusions $GL_1(R)$! $B^{cy}GL_1(R)$ and ¹(*R*) ! THH(*R*) have compatible left inverses in the homotopy category, where by compatible we mean that these splittings are related by a homotopy commutative diagram

We then de ne $_R$ to be the composite homotopy class

R: $BGL_1(R)$! K(R) ! THH(R) ! (R) :

Using the diagrams (4.8) and (6.1) we get an alternative description as follows.

Proposition 6.2 The homotopy class $_{R}$ is represented by the composition $BGL_{1}(R)$! $L(BGL_{1}(R))$ $B^{cy}GL_{1}(R)$! $GL_{1}(R)$;

(where the rst map is the inclusion of the constant loops), followed by the inclusion of $GL_1(R)$ in ${}^1(R)$.

This concludes the rst part of the proof of Theorem 1.2. In order to motivate the construction, consider the cyclic bar construction of a commutative monoid G. In this case the inclusion $G \, ! \, B^{\text{cy}}(G)$ is split by degree-wise multiplication in G. This can also be expressed in terms of the -space associated to G: The sequence $G \, ! \, B^{\text{cy}}G \, ! \, BG$ is the e ect of evaluating G on the co bration sequence $S^0 \, ! \, S^1_+ \, ! \, S^1$, and the splitting is induced by the projection $S^1_+ \, ! \, S^0$ that maps S^1 to the non-base point in S^0 . Let now $GL_1(R)$ be the -space de ned in De nition 5.5. The next Lemma shows that we may replace $B^{\text{cy}}GL_1(R)$ by $GL_1(R)(S^1_+)$ up to homotopy.

Proposition 6.3 Let X be a convergent and commutative I-monoid. Then there exists a space W^{cy} and equivalences

$$B^{cy}X_{hl}$$
 ! $W^{cy} = X_{hl}(S^{1}_{+})$:

Proof Let W^{cy} be the cyclic space

 $[k] \ \mathcal{I} \quad \underset{I^{k+1} \ D(S_{k+1}^{1})}{\text{hocolim}} X(n_0 \ t_0) \qquad X(n_k \ t_k);$

where is an object of $D(S_{k+}^1)$ and we write $i = u_i$. We have functors $I^{k+1} ! I^{k+1} D(S_{k+}^1) D(S_{k+}^1)$ obtained by xing the initial object in one of the factors. The cyclic structure of W^{cy} is the obvious one such that the induced maps

$$B^{\text{cy}}X_{hl}$$
 ! $W^{\text{cy}} = X_{hl}(S^{1}_{+})$

become maps of cyclic spaces. Since we assume that X is convergent, it follows from Bökstedt's approximation lemma 2.1 (with I^{k+1} instead of I), that these maps are equivalences in each simplicial degree. After realization we thus get a pair of equivalences relating $B^{cy}X_{hI}$ and $X_{hI}(S^1_+)$.

Remark 6.4 The condition that X be convergent is necessary for the argument in Proposition 6.3, since otherwise the map

$$X(m)$$
 ! hocolim $X(m t n)$

induced by the functor $I ! I^2$, $\mathbf{m} \mathbf{V}$ (\mathbf{m} , $\mathbf{0}$) need not be an equivalence. The I-monoid $X(n) = X^n$ considered in Section 4 provides a counter example. It should also be noted that the construction of the simplicial map $B X_{hI} ! X_{hI}(S^1)$ in the proof of Proposition 5.3 cannot be applied to give a cyclic map $B^{\text{cy}} X_{hI} ! X_{hI}(S^1_+)$.

Using the above equivalences, we de ne the splitting r to be the composite homotopy class

$$r: B^{cy}GL_1(R) \land GL_1(R)(S^1_+) ! GL_1(R);$$

where the last map is induced by the projection S_{+}^{1} ! S^{0} .

We next consider a version $\text{TH}^{\ell}(R)$ of topological Hochschild homology that relates to TH(R) as $GL_1(R)(S_+^1)$ relates to $B^{\text{cy}}GL_1(R)$. By de nition this is the realization of the cyclic spectrum

$$\mathrm{TH}^{\ell}(R;n): [k] \, \mathbb{I} \, \operatorname{hocolim}_{D(S^{1}_{k_{+}})} \, \stackrel{ot \quad t_{k}}{\longrightarrow} (R_{0} \, \stackrel{\wedge}{\longrightarrow} \, R_{k} \, \stackrel{\wedge}{\longrightarrow} S^{n});$$

where denotes an object in $D(S_{k+}^1)$ and we again write $_i = _{U_i}$. The cyclic structure maps are de ned as for $GL_1(R)(S_{+}^1)$. For example, in spectrum degree zero, d_0 : THH^{ℓ}₁(R) ! THH^{ℓ}₀(R) is the composition

$$\underset{2D(S_{1+}^{1})}{\text{hocolim}} \quad {}^{0^{T}_{1}}(R_{0} \land R_{1}) \not ! \quad \underset{2D(S_{1+}^{1})}{\text{hocolim}} \quad {}^{0^{1}}(R_{01}) \not ! \quad \underset{2D(S_{0+}^{1})}{\text{hocolim}} \quad {}^{0}(R_{0}) :$$

Here $_0 ! _{01} _1$ denotes an object in $D(S_{1+}^1)$ and the rst map is induced by the natural transformation that takes $f 2 _{0}^{t_1}(R_0 \land R_1)$ to the element in $_{01}^{01}(R_{01})$ given by the composition

$$S^{01} - \overline{I}^{1} S^{0t} = S^{0} \wedge S^{1} - \overline{I} R_{0} \wedge R_{1} - \overline{I} R_{0t} + R_{0t} + R_{0t}$$

where : $_0 t_1 ! _{01}$ is the bijection determined by . The second map is induced by the natural transformation $d_0: D(S_{1+}^1) ! D(S_{0+}^1)$. With this de nition we have the equality

$$d_0 = d_1$$
: TH^{*l*}₁(*R*) ! TH^{*l*}₀(*R*)

and consequently the iterated boundary maps give a well-de ned cyclic map r: $\operatorname{TH}^{\ell}(R)$! $\operatorname{TH}^{\ell}_{0}(R)$, where the target is considered a constant cyclic spectrum. In spectrum degree zero we thus get a cyclic map of spaces

$$r: \operatorname{THH}^{\ell}(R) ! ^{1}(R).$$

The next proposition is the analogue of Proposition 6.3.

Proposition 6.5 The spectra TH(R) and $TH^{\ell}(R)$ are related by a pair of equivalences.

the proof proceeds exactly like the proof of Proposition 6.3.

As in the de nition of the trace map we consider the transformation

 ${}^{0}(R_{0}) \qquad \qquad (R_{k}) ! {}^{0t}{}^{t}{}^{k}(R_{0} \wedge \wedge R_{k})$

that sends a tuple of maps to their smash product. Viewing these maps as natural transformations of $D(S_{k+}^1)$ -diagrams we get a cyclic map

$$GL_1(R)(S_+^1)$$
 ! THH^U(R):

It follows immediately from the denitions that this map is compatible with the splittings of $B^{cy}GL_1(R)$ and $\text{THH}^{\ell}(R)$ in the sense of the following proposition.

Proposition 6.6 There is a strictly commutative diagram of spaces

The homotopy commutative diagram (6.1) in the beginning of this section is derived from this using the equivalences in Proposition 6.3 and Proposition 6.5.

7 The Hopf map and free loops on in nite loop spaces

In this section we nish the proof of Theorem 1.2 by showing that the composite homotopy class

$$BGL_1(R)$$
 ! $L(BGL_1(R))$ $B^{cy}GL_1(R)$! $GL_1(R)$

is multiplication by in the sense explained in the introduction. More generally, let *G* be a very special -space and let $g = fG(S^n)$: $n \quad 0g$ be the associated -spectrum. By [4, 4.1], the -space *G* is determined by *g* in the sense that

the diagram

$$G(X)$$
 ! hocolim ${}^{n}G(S^{n} \wedge X)$ hocolim ${}^{n}(G(S^{n}) \wedge X)) = {}^{n}(g \wedge X)$

speci es a natural equivalence $G(X) \stackrel{\prime}{} (g^{\wedge} X)$. Evaluating G on the based cyclic set S^{1}_{+} gives a cyclic space $G(S^{1}_{+})$. The realization $G(S^{1}_{+})$ then has a \mathbb{T} -action and, as in the case of the cyclic bar construction, we consider the composite map

$$\mathbb{T} = G(S^{1}_{+}) ! G(S^{1}_{+}) ! G(S^{1}_{+})$$

with adjoint $G(S_+^1) \not = L(G(S^1))$. In the next proposition we analyze the homotopy bration sequence obtained by evaluating *G* on the co bration sequence $S^0 \not = S_+^1 \not = S_-^1$.

Proposition 7.1 There is a commutative diagram of homotopy bration sequences

in which the the vertical maps are equivalences.

Proof The commutativity of the right hand square is immediate since we evaluate a loop at the unit element of \mathbb{T} . In order to prove commutativity of the left hand square we recall that for any cyclic space X, the \mathbb{T} -action on the zero simplices $X_0 \quad jX \ j$ has the following description. If x is an element of X_0 and $u \ 2 \mathbb{T}$,

$$u x = [t_1 s_0 x; u] 2 jX j:$$

Here t_1 is the cyclic operator in degree one and we make the identi cation $\mathbb{T} = {}^{1}= \mathcal{Q} {}^{1}$. Using this, it is easy to check that the composition

$$\mathbb{T} = G(S^0) \ ! \ \mathbb{T} = G(S^1_+) \ ! \ G(S^1_+) \ ! \ G(S^1_+) \ ! \ G(S^1)$$

$$\mathbb{T} \quad G(S^0) \mathrel{!} S^1 \land G(S^0) \mathrel{!} G(S^1);$$

which shows that the left hand square in the diagram is also commutative. \Box

In Diagram (7.2) the map $L(G(S^1_+))$! $G(S^1)$ in the lower sequence is split by the inclusion of the constant loops, and the map $G(S^0)$! $G(S^1_+)$ in the upper sequence is split by evaluating G on the projection r: S^1_+ ! S^0 that maps S^1 to the non-base point of S^0 . The next proposition expresses the fact that these splittings are not compatible in general. As usual $2 {}_{1}^{s}(S^0)$ denotes the stable Hopf map.

Proposition 7.3 Using the natural equivalences ${}^{1}(g \wedge S^{1}) \vee G(S^{1})$ and ${}^{1}(g) \vee G(S^{0})$, the composite homotopy class

$$G(S^1) ! L(G(S^1)) = G(S^1_+) ! G(S^0);$$

is given by $^{1}(g^{\wedge})$.

Proof We rst observe that (7.2) is in fact a diagram of in nite loop spaces and in nite loop maps, and that as such it is equivalent to the following diagram of spectra

$$g \stackrel{\wedge}{\underset{j}{\sim}} S^{0} \xrightarrow{---} g \stackrel{\wedge}{\underset{j}{\sim}} S^{1}_{+} \xrightarrow{----} g \stackrel{\wedge}{\underset{j}{\sim}} S^{1}$$

$$F(S^{1}; g \stackrel{\wedge}{\atop{}} S^{1}) \xrightarrow{----} F(S^{1}_{+}; g \stackrel{\wedge}{\atop{}} S^{1}) \xrightarrow{------} F(S^{0}; g \stackrel{\wedge}{\atop{}} S^{1}):$$

Here $F(-;g \wedge S^1)$ is the obvious function spectrum and the upper and lower co bration sequences are both induced from $S^0 ! S^1_+ ! S^1$. These co bration sequences have canonical stable splittings induced by the projection $r: S^1_+ ! S^0$ and the associated stable section $s: S^1 ! S^1_+$. The vertical map in the middle is the adjoint of

$$S^1_+ \land g \land S^1_+ ! g \land S^1_+ ! g \land S^1_+$$

where the rst map uses the action of S^1 on itself given by the group structure. It is clear that the above diagram is equivalent to the one obtained by smashing g with

Here the de nition of is analogous to the de nition given above. We must prove that the stable map

$$S^{1} = F(S^{0}, S^{1}) \oint F(S^{1}, S^{1}) \land S^{1}_{+} \oint S^{0}$$

represents . Using the canonical splittings to represent $^{-1}$ as a 2 2 matrix, this composition represents the o diagonal term. It is therefore the negative of the composite stable map starting in the upper right corner of the diagram,

 $S^{1} \stackrel{i}{!}{}^{S} S^{1}_{+} \stackrel{i}{!} F(S^{1}_{+}; S^{1}) \stackrel{i}{!} F(S^{1}; S^{1}):$

The adjoint of this is the stable map

$$S^{1} \wedge S^{1} \stackrel{s_{1}}{!} \stackrel{s_{2}}{!} S^{1}_{+} \wedge S^{1}_{+} \stackrel{!}{!} S^{1}_{+} \stackrel{!}$$

where the second map is the group multiplication in S^1 . It is well-known that this composition represents \cdot . For example, one can see this by considering the equivariant splitting ${}^{\bigcirc}S^1 \cdot S^1_+$, whose domain is the unreduced suspension of S^1 , and then use that the map of homotopy colimits induced by the diagram

$$S^1$$

represents a generator of $_{3}(S^{2})$, cf. [22, XI.4]. The result now follows since has order two.

Proof of Theorem 1.2 The only thing left to prove is that the homotopy class $BGL_1(R)$! $GL_1(R)$ considered in Proposition 6.2 agrees with the one in Proposition 7.3 when the -space in question is $GL_1(R)$ and we use the canonical equivalence $BGL_1(R)$! $GL_1(R)(S^1)$, cf. Proposition 5.3. Let W be the realization of the simplicial space

$$[k] \mathbb{I} \operatorname{hocolim}_{l^{k} D(S_{k}^{1})} X(\mathbf{n}_{1} t_{1}) \qquad X(\mathbf{n}_{k} t_{k}) :$$

Since the space W^{cy} considered in Proposition 6.3 is the realization of a cyclic space it has a \mathbb{T} -action, and the adjoint of the composition

$$\mathbb{T} \quad W^{\text{cy}} \mathrel{!} \quad W^{\text{cy}} \mathrel{!} \quad W$$

gives an equivalence W^{cy} ! L(W). It easily follows that we have a commutative diagram of equivalences

It thus su ces to check that the homotopy class de ned by the diagram

 $BGL_1(R)$! W $GL_1(R)(S^1)$

is compatible with the canonical equivalence $BGL_1(R)$! $GL_1(R)(S^1)$. We do this by exhibiting an explicit homotopy inverse of the equivalence $GL_1(R)(S^1)$! W. Let W^{ℓ} be the realization of the simplicial space

Ordering the *k*-simplices S_k^1 as in the proof of 5.3 gives an equivalence $W \, ! \, W^{\emptyset}$. Moreover, using the monoidal structure of I we get a functor $D(S_k^1) \, D(S_k^1) \, ! \, D(S_k^1)$. Varying *k* this is a transformation of simplicial categories and consequently there is an induced simplicial map $W^{\emptyset} \, ! \, GL_1(R)(S^1)$. It is easy to check that the composition $W \, ! \, W^{\emptyset} \, ! \, GL_1(R)(S^1)$ is a homotopy inverse of the map in question and that the composition with $BGL_1(R) \, ! \, W$ is the canonical equivalence. This completes the proof.

Remark 7.4 The discussion in the above proof can be generalized to any commutative *I*-monoid *X*. If *X* is convergent, $B^{cy}X_{hI}$ and $X_{hI}(S^1_+)$ are

related by cyclic equivalences as in Proposition 6.3, and if X is group-like we get equivalences relating the same spaces by comparing them to the relevant free loop spaces. In case X is both convergent and group-like, the two equivalences agree by an argument similar to the above.
